Lets keep our partnerships with a purpose and passion to drive greater progress in the coming year and beyond.







WiLAT Global Council Meeting (WGC)





CILT International Convention October 23 - 26, 2022 - Highlights

CILT International convention was held after a lapse of three years in Perth Australia from 24th to 26th October 2022. The International convention was kick-started on day 1 of the industry program with Western Australia's Parliamentary Secretary for Transport, Planning and Ports, Jessica Stojkovski, followed by a welcome from CILT International President Paul Sainthouse and the Secretary General Mark Armitage and Australia's National Chair Kim Hassall.

This was followed by several industry sessions throughout the day, with key presenters; Lyle Banks, Pilbara Ports, Dr Emmanuel Onwond, Alex Clifton, Student Member, from Edith Cowan University and Dr Catherine Lou, Chairperson of WiLAT Australia, also from Victoria University.

Following the morning break we had panel sessions commence with Karyn Welsh, CEO of CILT Australia. The sessions started with Luke James, COO from NP Fulfillment, followed by Leigh Williams, Founder and MD of eStore. Sessions in the Freshwater Bay Room focused on Education and what businesses are wanting from Logistics education. Prof Marcin Paweska from Poland presented the topic 'What Business wants from Supply Chain Education', followed by Commander Fiona McNaught, from the Royal Australian Navy, joined by Kim Hassall, National Chair of CILT Australia, who presented the Professional Standing of the Certified Professional Logistician (CPL), a certification awarded to individuals. In the Plaza Ballroom, Paul Sainthouse, CILT International President, Chaired the session on Buses where presenter Jonathan Anderson, Sustainable Mobility Manager from Keolis Downer presented on the Keolis Downer Sustainable Directions with Hydrogen. Les Bruzsa, from National Heavy Vehicle Regulator, then followed with his presentation on Double Articulated Buses.

The second half of the day saw sessions on Innovation in Supply Chain and Road Freight Safety and Productivity, Training for your business Future and in the Plaza Ballroom WiLAT discussed the developments, successes, and international industry challenges for women globally working in the profession. In the Grand Ballroom, Cam Dumesny, CEO of Western Roads Federation, Heather Jones, CEO of Pilbara Heavy Haulage Group and Marcus Kelly, Compliance /Training Manager, Dyer Transport, all addressed the theme of Developing Heavy Vehicle Drivers - a Universal Problem. Bill Manton, National Trainer at Simons Transport concluded the session. The Freshwater Room covered Aviation and the theme of Recovering from the Pandemic. Presenters included Karmjit, President CILT Singapore and Korum Ellis, CEO FlyOnE who discussed Australia's first Electric Aircraft (EV Aviation) and its use in Queensland and Western Australia. In the Plaza Ballroom, Jan Steenberg, Honorary Secretary of CILT International presented the Vision for Our Professional Development area moving forward. WiLAT's head of the Capacity Building Centre (WCBC), Vicky Koo followed with a presentation on the WiLAT Capacity Building Centre, which was established with an aim to develop female leadership; and to encourage knowledge acquisition of the latest industry trends for advancement in our ever-changing world of supply chain, logistics and transport. This was followed by the Global Mentoring Workshop.

The sessions ended and delegates enjoyed a dinner that included the exchanging of the Chain between the immediate past International President, Dato Radzak Malek to the current International President Paul Sainthouse. This was the first opportunity to come together and officiate the "Exchange of the Chain" post COVID, as an International Delegation.

After a very exciting day one, day two began in the Grand Ballroom with a focus on Humanitarian Logistics Post Pandemic with a focus on the developments in operations and technology. Commander Fiona McNaught from Royal Australian Navy presented some case studies on military involvement and learnings from Australia's recent natural disasters. Jennifer Bottrell, Humanitarian Logistician, MAF presented on Aviation Logistics in a Humanitarian and Development context, this was followed by Ryan Underwood, CEO Denba who presented on Transport Innovation that may prevent food disasters.

The Freshwater room saw presenters from Malaysia, Nigeria and Australia present on various Supply Chain Strategies that involved Rail. The Plaza Ballroom also had presenters discuss Network restructures, City Logistics and Port Hinterland Logistics Costs. These were followed by Panel discussions before the morning break.

The late morning session began the Grand Ballroom with a focus on Safety. Sarah Jones, Transport Consultant and Director of Healthy Heads Trucks Chaired the session. Adam Gibson, Risk Engineer of National Truck Insurer, followed by Jerome Carslake, Director, National Truck Accident Research Centre, Monash University, who presented to the global audience on the National Road Safety Partnerships Program. In the Freshwater Room Berna Akyildiz, Vice President of TGL Transtas Global Logistics, spoke on Turkey as a Logistics Hub. This followed with presentations from Malaysia, Indonesia, North America, Australia, Central Asia and Southeast Asia on the International Business Forum and the progress that has been made to date.

Following the lunch break the focus in the Grand Ballroom moved to Shipping. George Vrakas, Patrick Stevedore presented on the Global Pandemic Impacts on the Waterfront, followed by Phillip Norman, Chairperson, CF Technologies. The Freshwater Bay room focused on a very interesting topic on Brexit Impacts on the Supply Chain. Jan Steenberg, CILT's Honorary Secretary chaired the session where he was joined by Kevin Byrne, past International President and Sharon Kindleyside, CEO CILT UK. This was a very entertaining session and many found the information very enlightening.

The last speakers in the Grand Ballroom focused on Sustainability and New Fuel Adoption. Dr Michael DePercy Senior Lecturer, University of Canberra, discussed the possibilities for Hydrogen. Sam Oswald from Arup spoke on the Hydrogen Corridors and was followed by Diane Edwards, President CILT New Zealand.

The Freshwater room had CILT Australia's CEO Karyn Welsh and Jenny Riano, Manager of CILT Australia's Marketing presenting and demonstrating the HigherLogic Community Platform that CILT Australia has implemented and its progress over the first 12 months. The Plaza Ballroom conducted a Strategic Planning session and followed with all CILT Members joining together for CILT International's Annual General Meeting. The delegates had a short break before moving to the Gala Dinner that was held at Beaumonde on the Point. At the awards ceremony CILT International's Young Professional Award went to Andrew Leung from Hong Kong, followed by Australia's Young professional Award which went to Saul Bosh. The Professional Woman's award went to Heather Jones from Pilbara Heavy Haulage Girls. The gala dinner guest speaker Rosco Mc Glashan from Perth spoke about the 'Aussie Invader', the vehicle being primed to launch an assault on the world land speed record, with 1000 mph being the target. Rosco is already the "Fastest Aussie on Earth".

Day 3 began with the industry site tours to Fremantle Port, Driver Risk Management Truck Education Centre, the Perth Underground Bus Port, and the Linfox intermodal terminal.

She is known among the fraternity as a fearless leader and an impactful mentor with lots of valuable insights to offer to anyone who is willing to ask/ learn.

Q. You are known to be an all-rounder with excellent academic and professional achievements. When it comes to your career, you have four decades of rich work experiences and leadership achievements. Would you brief us on your remarkable career journey thus far?

First and foremost, I would like to attribute everything I have achieved thus far in my career to God Almighty, for His faithfulness towards me. My

journey of building a career in the transportation sector started in the year 1981. Early in my life, I always wanted to create positive value through the leadership of zestful men and women in the pursuit of economic growth and development, through facilitation of logistics and trade in Nigeria. Achieving this requires a motivated, vibrant, proactive and passionate character, which is self-trained in order to step out of one's comfort zone. The quest to achieve all these and more, led me to obtaining postgraduate degrees, diplomas and professional certifications at the University of Cardiff; Tilbury Training Institute, London; Harvard University, Boston and International Chambers of Commerce, Paris. These platforms have been part of my propellers through these four decades of my career and towards achieving the various milestones known by all. Notwithstanding the intensive training, I took risks in changing jobs and challenging the status quo. In some cases, I started projects that most people in my organisation were not familiar with by thinking outside the box. Marcel

Proust said, "the real voyage of discovery consists not in seeking new land but seeking with new eyes". So, developing a growth mindset, as well as recognizing, accepting my mistakes and learning from the mistakes of others have played a key role in my becoming. I decided never to strive for recognition but rather strive for accomplishment and while doing so, being open to criticisms as something positive and as an opportunity for growth. While also setting aside time to focus on things that matter the most, rearranging and prioritising my schedules as well as creating better understanding and clarity on important issues.

Affirmation from superiors, risk appetite, dedication, ability to learn with available tools and relearn with integrity, trainability, focus, commitment and resilience became my guiding principles. I asked questions, applied myself and always asked for opportunities to serve. It is also important to say that my professional journey would not be complete without CILT and WiLAT, as they have served as a take off point for some of the achievements attributed to me.

Q. You were recognized as a “Maritime Amazon” by the Maritime industry in Nigeria, especially for your service in the public sector through various positions held in the presidential and ministerial committees shaping industry related policies. Please brief us on some of your involvements there and how did it support your career in return?

The title “Maritime Amazon” was ascribed to me after I was selected to be the Face of Maritime International (FOMI) in 2017, because of my role in promoting and encouraging gender diversity for girls in colleges and amongst sea-going maritime professionals. FOMI is a pet project tagged “Girls go to sea” that uses role modelling to champion gender advocacy, mentorship and women empowerment in the maritime industry. In addition, my involvement in numerous Inter-Ministerial and Presidential committees, spanning a period of over forty years, have been some of my proudest moments through my professional journey until now. To mention a few;

- ▶ Coordinator of the Committee on Cross Border Trade – aimed at encouraging Intra- African trade through Transport and Trade Facilitation as well as setting up Border Information Centers (BIC) and Shipper’s Information Centers (SIC) at some Nigerian Borders.

- ▶ Chaired and participated in meetings/negotiations of the UASC (Union of African Shippers’ Councils) expert Committee Meetings (LOME and Cotonou roundtable of negotiations). The meetings were maritime economic meetings (involving the World Bank, IMF, IFC and multinational shipping interests) to consider and address economic problems encountered by all key players in the West and Central African Sub-region.
- ▶ Member, Inter-Ministerial Committee set up to prepare the initial draft for a work plan for the implementation of International Safety and Security Code (ISPS) for which a Presidential commendation was given in 2004.
- ▶ Anchored WTO Trade Facilitation Committee and ‘National Self-Assessment Needs Committee’, aimed at addressing institutional and structural bottlenecks in trade and expedite the movement, clearance and release of goods, including goods on transit as well as technical assistance / capacity building in this area.
- ▶ Coordinated the Presidential / Petroleum Trust Fund (PTF) Committee on the Terms of Reference (TOR) for the Dredging of the lower Niger from 1998 - 1999.

- ▶ Crafted a roadmap for the UASC’s introduction of Cargo Tracking Note (CTN) in 1998 and chaired the lobbying group to advocate to Heads of Governments for its implementation in 20 countries of Africa.

- ▶ Was part of the African Think-Tank of the negotiations in committee No. 3 of the United Nations Commission on Trade Law (UNCITRAL) for ROTTERDAM RULES (A negotiation that lasted years-held often in Vienna and New York)
- ▶ Coordinator of the First Meeting of African Ministers Transport Conference, Abuja, 19 -23 Feb 2007 with 54 Countries in attendance.
- ▶ Chairperson Ministerial Committee on Revamping Activities at the Nigerian Eastern Port in 2015.
- ▶ Secretary/Member to the Presidential Committee on the Sale/Acquisition of Five Nigerian National Shipping Line (NNSL) vessels (1995 -1996). (This translated to my appointment as the first female General Manager of the Nigerian Unity Shipping Line.)

- ▶ I retired from public service as Director Commercial Shipping Services where I had responsibility for regulating freight rates, benchmarking shipping services, assessing the conditions and analysing the supply and performances of shipping service providers.
- ▶ Currently serving as the Chairperson of the Sealink Implementation Committee/ Consortium. A project born from my years of experiences and exposure in the transport industry. It is viewed continentally as a game changer for African trade, as it seeks to provide trade connectivity and access to markets for Africa

The friends, colleagues and professional relationships I built through these involvements have also become support systems towards greater success and accomplishments. I didn't just participate and contribute positively to the success of these committees, I met with countless splendid personalities and extraordinary achievers and interactions with them drove me towards becoming better and in turn promoting growth in the transport sector in Nigeria and Africa.

Q. You joined the WiLAT Global Advisory panel in 2019. Since then and even before that you have played an important role in WiLAT international growth and in the establishment of WCBC. Would you like to share more of your contributions at WiLAT?

From inception, I saw the potential of WiLAT becoming a strong international platform of advocacy for women in transport and logistics. In my capacity as an Advisor, through forward thinking with WiLAT Global leadership Dr. Dorothy Chan, Past Global Chairperson; who was instrumental to my appointment, Mrs. Gayani De Alwis, current Global Chairperson; Dr. Doreen Owusu-Fianko, Deputy Global Chairperson and Vicky Koo, Head of WCBC, I advised and supported the establishment of the WCBC (WiLAT Capacity Building Center) in a bid to promote sustainability in capacity building, as one of the five pillars focused on by the current WiLAT Global Chairperson and her predecessor. The WCBC is more robust, educative and validates the knowledge of female professionals in the institute, in place of the regional CALF Programme.

Also, I volunteered to be a trainer in one of the series in a bid to foster mentorship and inculcate capacity building prowess and diversity in members. Notwithstanding, I was trained in the WCBC program, where I learnt more about circularity, sustainability, digitalization and changing the mind-set to encourage inclusiveness.

Q. Would you share with us a memorable experience of yours at WiLAT Global?

Everything about WiLAT Global has been memorable but what stands out for me, is the love, togetherness, support and purpose demonstrated by the leadership and regional groups, with the willingness and openness to learn new skills and impact others.

Like I mentioned earlier, every moment since I joined WiLAT Global has been memorable and teachable. I would like to appreciate WiLAT for providing an environment that fosters mentorship, as I have discovered through my journey that it is in fact one of the best ways to preserve and promote sustainability. In all that I have accomplished in my career thus far, nothing gives me greater joy than impacting a generation of young professionals growing through the ranks to hold key positions in the industry.

One of the most profound quotes I have come across is one by Robert G. Ingersoll, "We rise by lifting others", a very short but deep-thinking statement that has consciously shaped my thought process through every decision in the course of my life. WiLAT Global leadership demonstrates this virtue visibly.

Q. Any message that you would like to share with CILT and WiLAT membership as they aspire to follow your footsteps?

I was a member of the CILT Nigeria Board of Trustees for years before I became WiLAT Global Advisor. Both roles require advice and trusteeship. From this standpoint, I can confidently say that hard work, consistency and dedication have all been cogs in the wheel of my success.

As a Senior training officer, I was exposed to leadership development programs and regular training and networking events which prepared me for the selection of vestibule training programs for 1,700 staff of the National Freight Agency in 1982. I also took advantage of mentorship in the organisation where great mentors mentored me.

Later, when I was transferred to the Nigerian Airways, I attended Basic I, II and Aviation Executive Training. In the Maritime industry, I was exposed to intensive, quality training in Universities and Colleges. This helped me understand my strengths and weaknesses, while creatively expressing and challenging myself by choosing a virtue that always supports my personal vision: self-development. This has always helped me to act more confidently even when I don't feel too confident.

My cardinal principles are commitment, self-motivation, mental resilience and teamwork. Sometimes it takes grass instinct to get policies, programs and projects to be accomplished in a timely manner through a strong team. As Andrew Carnegie puts it "The fuel that allows common people to attain uncommon results is teamwork". In the same vein, I urge all members of CILT and WILAT not to stop working hard nor investing in themselves, because "Self-investment is the best investment".

Romesh David FCILT was appointed as an Advisor to WILAT Global in January 2020 and served his tenure till December 2022. He is the CEO South Asia Gateway Terminals; one of the three container terminals in the Port of Colombo. SAGT is a public/private partnership between John Keells Group of Sri Lanka, the AP Moller/Maersk Group of Denmark, Evergreen Marine of Taiwan and the Sri Lanka Ports Authority. He has been a well-known promoter of women's leadership and involvement in the development of countries' trade and economy both inside and outside of WILAT Global.

Q. When it comes to your profile, we cannot go on without shedding some light to your career growth inside John Keells Holdings where you've spent over 40 years holding extensive operational and strategic roles. Could you navigate us on your career journey at JKH?

I started off with the John Keells Group (JKH), as a trainee at Walkers Tours, the inbound tourism division of the Group, where I spent the first 8 years. Thereafter, I moved into the airline division, handling the general sales agencies for several international airlines, after which I moved to overlooking a number of businesses in the Whittalls Group, following the acquisition of that Group of Companies by JKH in the early 1990s. Concurrently, I was also handling the overseas recruitment business at Mackinnon Mackenzie and consequent to the resignation of my good friend and former colleague, Niral Kadawatharatchie in 1992, began handling the international freight forwarding business as well. In the late 1990s, I was seconded to the JKH Joint Venture with P&O Nedlloyd (P&ONL) and served as the Country Head for Sri Lanka and the Maldives at P&ONL until the line was acquired by Maersk in 2004.

In 2005, I was appointed Sector Head and later President of all the JKH Transportation businesses, which included businesses in Sri Lanka, India and the Maldives in aviation, shipping, travel, logistics, air express courier, supply chain, freight forwarding, bunkering and ports, in which position I served until joining SAGT full time in 2018. During this period, I also served for a couple of years as the President of the JKH Information Technology Group, which included businesses in systems integration, software development and BPO operations in Sri Lanka and India. After the end of terrorist conflict prevailed in Sri Lanka, I was privileged to lead the team that set up Sri Lanka's first private scheduled domestic airline, Cinnamon Air, which today remains the primary and most versatile domestic airline in the country.

Q. You've held several honorary leadership roles in multiple industries and government institutions/committees including the National Agenda Committee on Transport and Logistics of the Ceylon Chamber and National Maritime Policy Formulation Committee. Can you share with us some key highlights in those roles you've served?

My first experience in an industry leadership role was as the Chairman of Sri Lanka Logistics and Freight Forwarders Association from 1998 - 2000. My exposure to the industry was bolstered hugely by my learnings under industry giants like Hanif Yusooof and Diren Hallock, under whose guidance, not only individuals like myself and a host of others, but also several national initiatives streamlining exports, imports and international trade facilitation, were launched.

This exposure gave me an appreciation that leadership roles in professional bodies, trade chambers and industry fora, require a mindset of working for the common good of the nation, industry and all stakeholders, which must always go beyond and clearly differentiate from, despite on occasion running counter to, the narrower interests of individual and/or company/business needs.

This insight served well in helping to navigate productive outcomes in several other industry and professional roles I have served in over the past two decades.

Q. You were the Past Chairman of CILT Sri Lanka from 2012 to 2014. During your tenure, Sri Lanka became a territory of CILT and WiLAT Sri Lanka forum was formed. In 2013, CILT Sri Lanka obtained the hosting rights to hold the CILT International convention in Sri Lanka and WiLAT Global forum was launched at the convention. You served on the Council of the CILT Sri Lanka until your appointment as an International Vice President for CILT South Asia. What do you have to say about the journey that CILT and WiLAT has come so far as a person who witnessed a great deal of its journey?

I owe my membership and involvement in CILT to Diren Hallock, who in addition to being an early mentor in the freight forwarding industry, also convinced me to obtain membership in CILT at the time he was Chairman of CILT Sri Lanka in the early 2000s.

The journey of CILT Sri Lanka over the past 20+ years has been truly sensational; growing from a one employee organisation, hosted free of charge at a desk in the late Rohan Abeywickrema's office, to a full-time Secretariat with several permanent employees and a membership that has grown more than five-fold. I was privileged to have worked and interacted with consummate professionals and industry leaders within CILT locally and globally, of the likes of the late Rohan Abeywickrema, Saliya Senanayake, Dr. Parakrama Dissanayake, Prof. Amal Kumarage, Cyril Bleasdale, Keith Newton, Prof. Allan Waller, Dr. Dorothy Chan, Steve Rinsler, Kevin Byrne, Aisha Ali Ibrahim, Dato Radzak Malek and Gayani De Alwis, to name a few.

Given that global WILAT was launched in Sri Lanka in 2013, WiLAT in particular is very close to my heart and was the beginning of and remains one of the main reasons for much of my engagement and support to drive greater female participation in the workforce across the transportation industry in general and of late, in the Port sector in particular. The passion and commitment of the women in WiLAT are an exemplary example of what women in leadership in the logistics and transport industry can do and the phenomenal spread in the WiLAT footprint and membership globally, is an ample testament to that. It sets an example that CILT International would do well to emulate.

Q. In which areas did you involve mainly as an Advisor to WiLAT Global, a well-deserved role you took up in January 2020?

The kudos for what WiLAT is today belongs to the many women and men leading the effort around the world, which I have been privileged to be associated with and support several of the initial WILAT global training programmes. Through those, I believe we have been able to set an impressive benchmark in the domain of online professional learning and development within CILT and the transportation industry in general.

Q. What do you think the future holds for WiLAT Global?

Naa Densua Aryeetey FCILT has taken over the role of WiLAT Global Advisor effective since October 2022 for a three year period. She is an Executive Member of the Governing Council of the CILT Ghana and has held several Senior Manager positions including that of the Ghana Shippers Authority and the Shipper Services and Trade Facilitation. Her experience and know-how in the field of Maritime and Logistics along with international regulations and policies will be a great strength to WiLAT Global growth ahead.

Q. You are a true epitome of a Maritime industry product. Your higher education was focused in the field of Maritime and since then you've served in several positions promoting and developing Maritime industry nationally as well as globally. Could you brief us on your career journey thus far?

I entered the Maritime Industry in 1991 when I had no clue of what pertains in the industry and how women fared in it. There was nothing like mentorship, or did I find many women in management positions at the time. I started at the Ghana Shippers Authority as an officer, in 1991. After three years of working, I had gained an appreciable understanding of the shipping industry under the mentorship of my boss who was then the CEO. I realised I had learnt on the job without realising it and had gained knowledge in the shipping terms and terminology, and operations at the port.

In 1994, I had the opportunity to undergo formal education in Port and Shipping Management at the International Maritime Transport Academy in Den Helder, the Netherlands where I had practical and theoretical training. I returned home and gained much practice as I was subsequently promoted to a higher level and posted to a more operational department. In this department, Shipper Services, I was responsible for shippers, (importers and exporters) their education and training, and to assist them in their day-to-day shipping and trade transactions and resolve problems associated with these transactions. I dealt with the large, medium and small-scale enterprises, logistic service providers, transport services and government agencies whose work had an impact on shippers. Later, as I continued my work with the Shippers' Authority, I gained admission to the World Maritime University in Malmo, Sweden, to

undertake my Masters in Maritime Affairs (Shipping Management). During my sojourn at the University, I was elected at a highly contested election to become the 2nd Woman President of the Student Council, for the class of 2003. I had the opportunity to be responsible for over 200 students from different parts of the world. As a female leader in a very male dominated environment, I had my fair share of challenges as I had to understand the diverse group in terms of gender, culture, religion, socio-economic backgrounds of the community. The percentage of women at the time was rather small.

The role of the President got me to serve on several boards, including the Governing Council of the University headed by the Secretary General of the International Maritime Organization, The Academic Board which was Chaired by the President of the University and the Student Monitoring Committee which was Chaired by the Administrative Head of the University. I Chaired the Student Council and led the students in several fora and academic adventures.

On my return, I was promoted to the

next level and posted to Head, one of the biggest Branches of the Authority in terms of staffing and finances. I headed the Branch for eight (8) years where I had the opportunity to extend the work of the branch to other regions of the country to assist shippers, logistic service providers and bring solutions to their doorstep. During my work at the Branch, I set up two very important Shipper Committees in two regions of Ghana. These Committees are made of shippers, logistic providers, transport operators, the Customs, government agencies who are involved in the day-to-day transport and trade transactions. Another important Unit set up was the Shipper Complaints and Support Unit at one of Ghana's borders between Ghana and Togo, for Cross-Border Traders. This Unit assists cross border traders, and transistors in their businesses.

I later in 2013 returned to the Head office, to Head the Department for Shipper Services and Trade Facilitation. This brought me sharply into Trade and Trade Facilitation for shippers, SMEs, and Cross Border Traders. I started a series on the Export forum where discussion was held on improving exports from Ghana, procedures at ports for exports, transportation and customs processes. This was done across the 16 regions of Ghana. My job focused on the education and training of shippers on the changes and trends in the National, Regional, and international shipping and trading industries. Shippers were alerted to new policies that could impact their trade transactions and affected their transport and logistic costs. Some of the highlights of the training were on Trade Facilitation, IMO laws and regulations on Verified Gross Mass (VGM), The African Continental Free Trade Agreement and its impact on businesses, Custom Procedures, and many more. My work at the Ghana Shippers Authority spanned a total of almost three decades working in the maritime, trade and logistic sectors.

Currently, I Chair Ghana's subcommittee on Trade and Gender, under the National Trade Facilitation Committee. This Technical Working Group has the responsibility of empowering Women in Trade, Women led small and medium scale business, providing the platform to address non-tariff barrier measure (NTM).

Q. You've rendered a great service to women in the Shipping and Logistics industry especially in the region of Africa with valuable initiatives and executive leadership roles you've taken up in several women focused organisations including that of CILT and WiLAT Ghana. Would you recall some of that with us?

My work with women started somewhere around 2005 when I had just been posted to head one of the busiest branches of the Ghana Shippers Authority. The Authority itself was very male dominated and did not have many women in Management positions. In fact, we were just about three women at the management level with the rest all male.

When I took up the position, I had this idea of creating a niche, in the industry for women, where their contribution would be recognized. I realised that women's role in either the maritime, Trade or Logistics sectors were hardly recognized, even though there were well qualified women at the time.

In 2010, I founded the Women's International Shipping and Trading Association (WISTA) Ghana Chapter, together with a few ladies and was its first President for seven years until 2017.

In 2015, I was elected to the Board of WISTA International as a Director/ Executive Committee Member, where I served for another seven years, until October 27, 2022. During my time with WISTA International, I served the Africa Region, was responsible for the Trade Committee and the Human Resource Committee. During this time WISTA International gained Consultative Status with the IMO, and also signed a Memorandum of Understanding for Technical cooperation.

After these, a Focus Group Africa, was established on my initiative, which comprised National WISTA Associations in Africa, and all IMO established Women in Maritime Associations (WIMAs) in Africa. This group was established to "Strengthen cooperation and best

practices shared between the IMO-established regional women in Maritime Associations (WIMAs) and WISTA International and its National Associations (NWAs)'.

I became a member of the Chartered Institute of Logistic and Transport, Ghana branch in 2005. I was elected as the Vice Chairperson of the Tema Section of CILT Ghana. In 2011, I was elected to the Governing Council of CILT Ghana, as the Vice President, Logistics where I served for a term, and stepped down. I have served as an Executive Member to CILT Governing Council since 2021 and also an Advisor to WiLAT Ghana.

On the Global side, in 2010, at the CILT international Conference in Valletta, Malta, the idea of establishing a Women in Logistics and Transport was pushed forward. Five women, with one idea, gathered to consider the idea of a Women in Logistics and Transport. I happened to be one of these women who decided it was about time to have professional women in the industry and to provide the necessary guidance, mentorship and training to build capacity. This was to increase the attendance of women at the CILT conferences as well as its membership.

I must say that I am very happy to see how that decision has come this far. I thank all who have contributed to this success. I played my role in the setting up of and inauguration of WiLAT Ghana in 2013.

Q. What do you think has been the best highlight of your journey so far and how has it helped you to shape your life and career for the better?

I have had a few highlights on my journey, very impactful but I will just mention one that put me on a global stage. This was my election to the World Maritime University (WMU) as President of the Student Council. It gave me the opportunity to work with various stakeholders and to understand a global community, diverse in culture, religion, socio-economic backgrounds and gender. It was important to understand and ensure that all was included.

As a woman leading a global student community, I learnt to be very understanding and appreciative of the different cultures I was working in. This really impacted my future work and relationship in the international Maritime and Trade communities that I currently work in. It also taught me good leadership skills which I am always improving upon.

Q. How do you plan to support WiLAT Global and its membership in the capacity of your new role as an Advisor to its Steering Committee?

I believe I could bring WiLAT Global a wealth of knowledge and experience over the many years in the transport, trade and logistics sectors. I also believe I bring in a breath of fresh air, to revitalise all. Trends in the industry, partnership and collaboration for sustainability is key and I hope to be able to contribute to the overall success of WiLAT Global.

Q. Any message that you would like to share with the readers of Wings of Change on what to possibly expect in the industry and perhaps how to navigate across rough seas?

I will say that collaboration is key. The world is finally accepting the role and importance of women in every facet of life. Be it women in maritime, women in trade, women in logistics and transport or STEM, women are pushing ahead, for recognition, visibility, and leadership.

WiLAT finds itself in a unique way, as the only Women's Association dealing with all the modes of Transport. Transport is a key sector for every economy and WiLAT will do well in harnessing this advantage and ensuring that its five main thrusts are achieved.

Mr. Lau is the CEO and Director of Pointline Enterprise Private Limited; a strategic consulting firm specialising in aviation, transportation, supply chain, ecommerce fulfilment, JV establishment and M&A integrations. He carries over three decades of diverse industry experience with him which would be a great asset to WiLAT Global and its course of action.

Q. Referring to your profile, I've gathered that you possess multidisciplinary expertise with much of senior leadership and cross-cultural management background. How did your journey to the top and amongst-the-best begin?

I started with a general accounting role, after graduation, with the Japanese shipping line, Nippon Yusen Kabushiki Kaisha (NYK Line) in Hong Kong. That was beneficial to practising what I learnt, from the

Accounting Institute, and applying theories into the commercial / international business environments. Through that year, I have established my interests in the transportations sector. Knowing my personal inclination of being fast-paced and would enjoy life in the fast-lane; I moved across the following year to join Malaysia Airline System (MAS), Hong Kong taking up the role of air-cargo sales for the next 5 years. During which I gained tremendous exposure in client engagements, air freight forwarder management, cargo terminal and ramp-side operations. Therein, I benefited from an important piece of advice from one of my industry mentors. He recommended me to dive deeper into the airfreight vertical, by investing a period of my career in the freight forwarder (3PL) segment to gain additional insights of the complex air cargo spectrum. I took his advice seriously, and subsequently accepted an offer to join the Airborne Freight Corporation (which operated as an independent company for 57 years, before being acquired by DHL, in August 2003) as their Marketing Executive. One of my key focuses was to manage the company's top US based customers, and their peak season chartered freighter-services between Hong Kong and the US midWest routing. I learned a lot from this tenure at Airborne, which contributed to my insightful exposure and hands-on experiences in managing the trans-Pacific air-charter freighters (B747F, DC8F), both the operational and commercial disciplines, and frontline employee teams engagement. That paved the way for my further growth and developments in the transport and logistics sector, throughout my career.

Q. At one point, you were sprinting up in the career ladder at TNT Express Worldwide, Hay Group and Rosenbluth International and precedingly, you played a key role in setting up Federal Express in Hong Kong. What made you to be this consistent and resilient all throughout?

Most thankfully, I was invited to join Federal Express Hong Kong in the mid-80's when their management observed what I'd done in Airborne Freight. They believed there were transferable experiences and my noticeable personal attributes could match well with the Federal Express corporate culture and the challenges a "start-up" business could face in the Asia markets; because FedEx believes in: PEOPLE - SERVICE - PROFIT, their people FIRST philosophy!

These observations of my personal attributes, and the inclinations of wanting to venture into uncharted courses, to build new organisations/ frameworks/ businesses, and most importantly enjoy interacting and working with people from different backgrounds/ nationalities/ cultures, have provided me with the various career paths and opportunities through my career life, leading to the APAC Vice President of Rosenbluth International, the regional Director of the Hay Group, Regional Director and the Managing Director of TNT Express Worldwide, and then the CEO of Jetstar Hong Kong Airways.

Q. It is right to say that you have given back to the community in many ways. Your contribution as a visiting lecturer and sometimes as a certified global trainer was selfless. When and how did you discover this side of you? What was your biggest achievement as an educator/ trainer?

I'd devout my thanks and gratitude to my two respected mentors at Federal Express and subsequently at TNT Express Worldwide.

During my FedEx tenure, I was offered the opportunity to become an International Sales Facilitator at their Corporate HQ in Memphis Tennessee, for a period of 2 years. There's been a culture at FedEx whereby they'd recruit top sales professionals from the field, and rotate these professionals into the sales training institute to train and develop the global sales teams, and the new recruits; the notion of the "Top Gun" academy. There, I've discovered the joy and sense of appreciation of grooming and developing new talents and helping others to unleash their potential and subsequently hearing their feedback of achievements after they returned to their own districts afterwards.

When I was managing TNT Express' businesses in the APAC region and their various county units, I led my teams to engage various local universities, technical institutes, and even high schools on the notion of creating awareness by engaging the next generations into the transport and logistics profession and also sponsoring their researches to explore the global trade and supply chain developments. We were able to attract a lot of high quality young adults into our management trainee programs, especially female graduates joining our company

from across Asia; that's effectively "demystified" the misperception that - logistics and transport sector is a male dominant profession. I'd been advised, they have continued these engagements through the years, and are able to attract and retain these highly capable individuals.

The global shipping industry is facing a new problem — too many containers



While there was a shortage of containers at the height of the Covid pandemic, the global economy is now facing the opposite problem: too many containers. On top of falling freight rates, data shows container depots — used to house containers after they are unloaded — are now filling up or full. It points to more signs of falling global demand and an impending economic slowdown. Traders and shippers say the decline in global consumer demand is not a sign the global economy is normalizing after a frantic post-lockdown consumption rush but a downward shift in consumption appetites.

Air Canada Cargo expands freighter fleet and network, and horses are back



Air Canada (AC) keeps expanding its network as more freighters join its fleet, and it has added horse traffic to its service line-up. This week AC Cargo is taking delivery of its third 767 freighter, which is expected to enter service after two to three weeks, and before the end of the year, the fourth should arrive. The first of the two new planes will be used to boost AC's Americas coverage, with flights serving Atlanta, Dallas and Bogota. The second will initially fill in for the carrier's first two cargo planes while they undergo service checks.

As the US trucking sector hits a slow curve, M&A activity goes up a gear



In a market facing headwinds, some players are consolidating their position through acquisitions, and in November Werner Enterprises, the seventh-largest US truckload carrier, took over Reed Transport Services and Ascend bought Fuchs Trucking. US truckers have rolled into the 2022 peak season at reduced speed. The Q4 market update and outlook by Uber Freight, released in November, shows a market that has lost much of the momentum of the past couple of years. Demand looks subdued while inventory levels remain high, whereas the number of trucks and drivers continues to rise.

The move brings together the integrator's 3PL arm, Coyote Logistics, same-day delivery provider Roadie, the Delivery Solutions platform and financial services provider UPS Capital. In addition, UPS will bring in its partnership with CommerceHub, aimed at building delivery density.

COP27: Collective bargaining may be a route to greener shipping



BCOs and forwarders can now negotiate collectively to buy biofuels, following the launch of a scheme at Cop, within the 'Roadmap to 2040' for Zero Emission Vessels (coZEV). The plans include a maritime 'buyers' collective bargaining initiative' to give shippers sufficient critical mass to push ship decarbonization. Announced at COP27, the Zero Emission Maritime Buyers' Alliance (Zemba) "will enable cargo owners to come together for greater impact and support accelerated deployment of scalable zero emission solutions in a robust marketplace," said Ingrid Irigoyen, director of the Aspen Institute Shipping Decarbonization Initiative and facilitator of coZEV.

Sustainable aviation fuel lands on award-winner CargoAi's booking platform



Freight forwarders can now check emissions data and purchase sustainable aviation fuel (SAF) when booking capacity on the CargoAi platform. SAF can be bought for one air waybill (AWB), or multiple AWBs, using the tech company's Cargo2Zero product, which aims to help customers decarbonize with a CO2 efficiency score. CargoAi won TIACA's sustainability award at the Air Cargo Forum in Miami in November 2022, voted for by delegates. While sustainability has been a focus of the event, smaller airlines remain unable to buy SAF, the most important route to reaching net zero by 2050.
