# Editor's Note




Dear Readers,

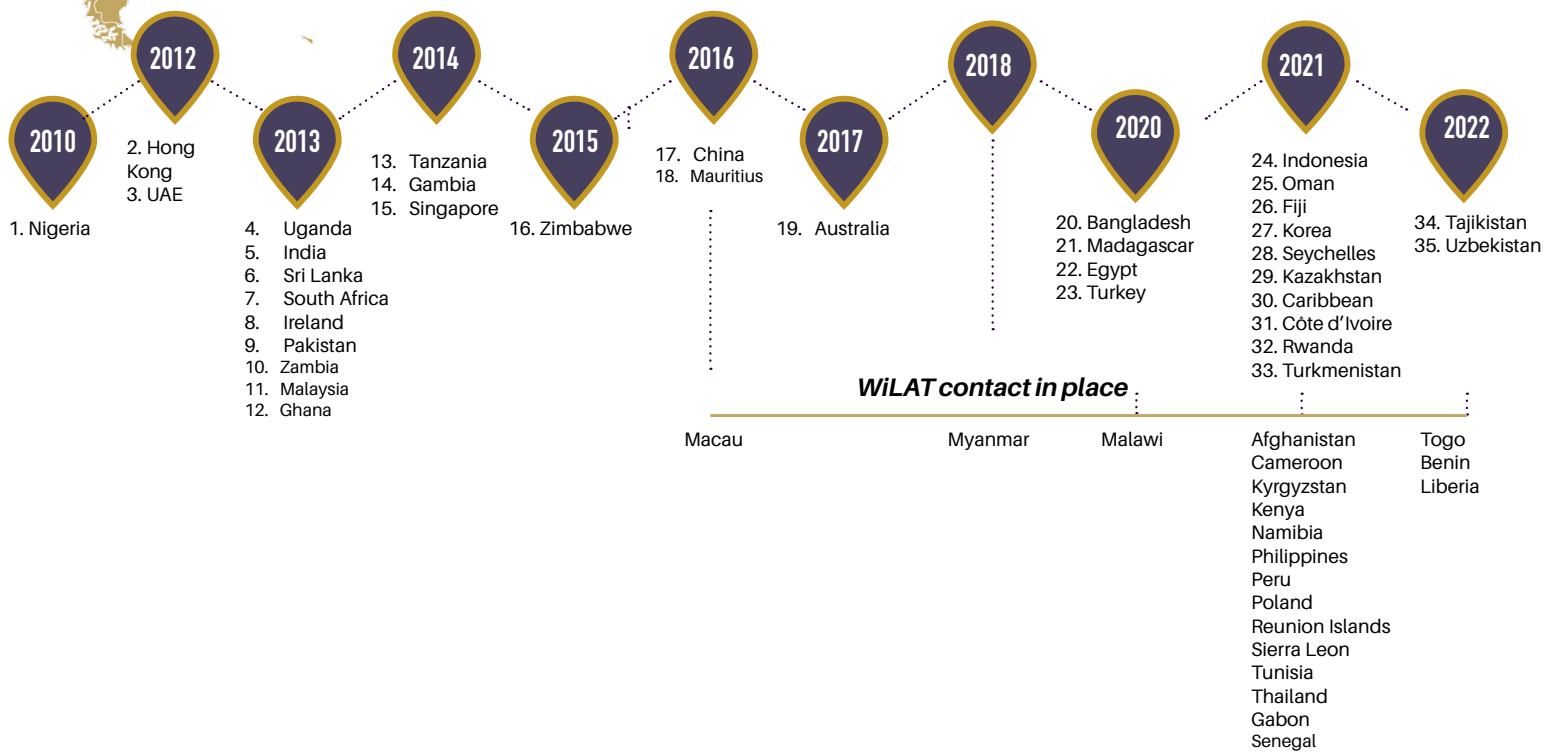
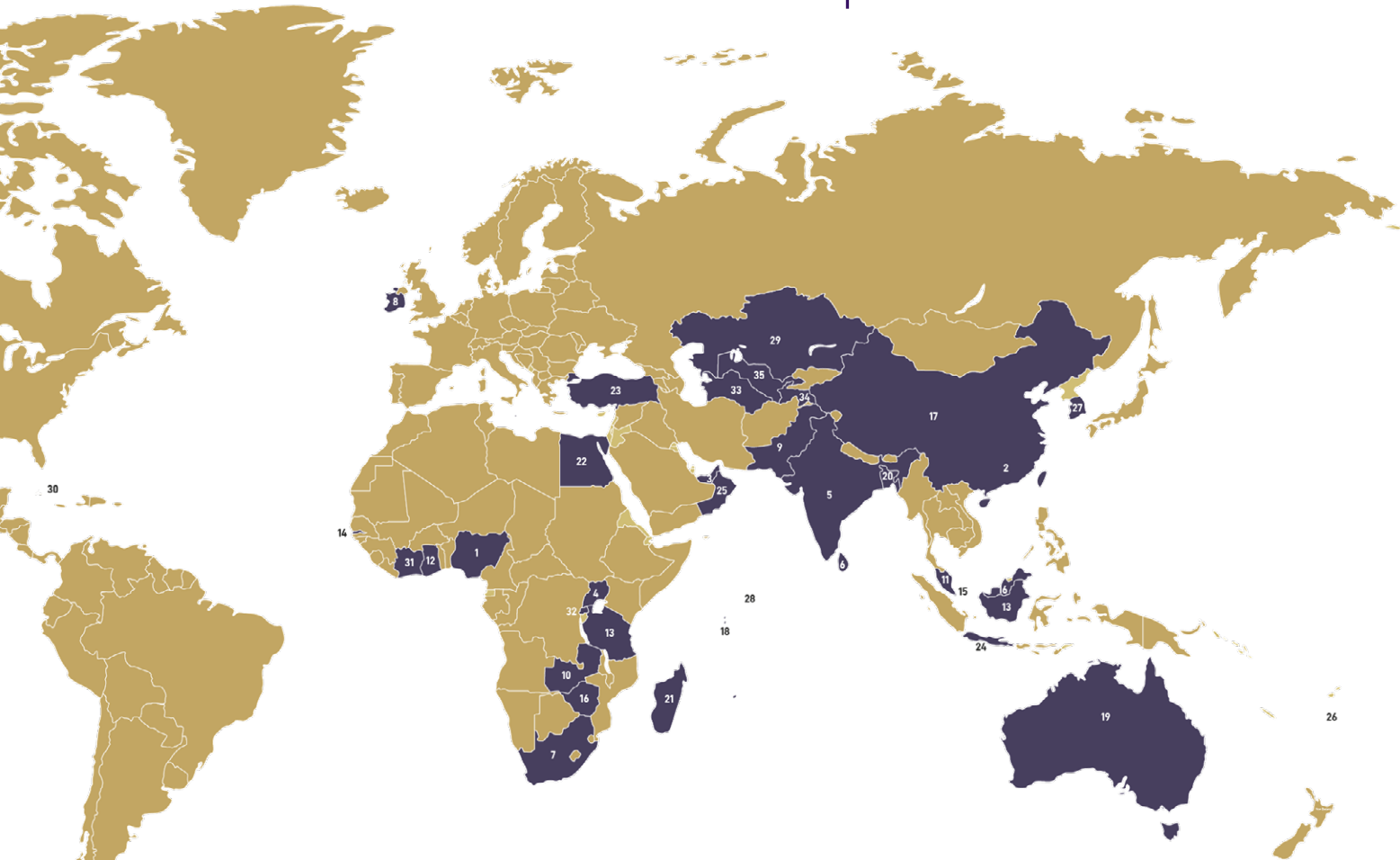

WiLAT Uzbekistan was launched in Tashkent becoming WiLAT 35th country and 4th country in Central Asia.

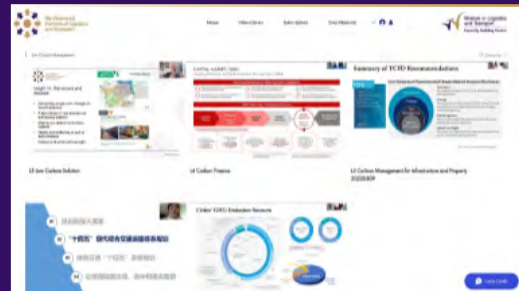




## WiLAT Capacity Building Centre (WCBC)

**Heather Jones**, Chief Executive Officer for Pilbara Heavy Haulage and Director/Owner of Success Transport will do a presentation about Pilbara Heavy Haulage Group. Heather Jones is a veteran heavy vehicle driver with over 25 years' experience in the Transport Industry. Beginning in 1985 and running Success Transport from 2005 until now. Operating numerous types of heavy vehicle configurations including: Oversize, 100 and 50 tonne Floats, Tankers, Side-Tippers, End-Tippers, General Freight, Double, Triple and Quad Road Trains and Low Loaders. Pilbara Heavy Haulage Girls Heavy Vehicle Driver Training Institute is the training institute she also established. Heather is also a Tow Truck operator for vehicle transport and recovery. Heather holds Cert IV in Training and Assessing, Cert IV in Heavy Vehicle driving Instructing and Assessing, WA Motor Vehicle Driving Instructors License, Forklift and loader tickets and is an Oversized Pilot Escort.



**Berna Akyildiz**, Vice President TGL Transtas Global Logistics and current Chairperson of WiLAT Turkey will do a presentation on Türkiye as a Logistic Hub: Opportunities and Gaps. Berna started her professional life at TGL Transtas Global Logistics in 1984, where she still serves as Vice President. As the first female entrepreneur in the male dominant logistics field, she has become a role model for women participation and level of employment in logistics. She has extensive knowledge in the Middle East and Africa, where she has completed the logistics of various construction and energy projects since 2000. Together with the associations of which she has been a member, she has recently been working on: Women in Logistics &Transport, Women in Africa, Logistics in Africa, Transit Hub Potential of Turkey. She also manages the Transtas offices in Cairo, Doha, Dusseldorf and the UAE. She has taught classes in project and art logistics in Kapadokya Collegiate School and Nisantasi University.



**Karyn Welsh**, Chief Executive Officer for the Chartered Institute of Logistics and Transport Australia - CILT Australia and Co-Director for Industrial Logistics Institute, shall do a presentation on e-Freight markets: Trials and Tribulations. Karyn Welsh has extensive experience in logistics and e-commerce, having previously been CEO of Go-Freight and Managing Director of Australia Post's corProcure division. Karyn is also a highly experienced Senior Manager with a broad and diverse background gained predominantly in change leadership roles within a Government Business Enterprise, Manufacturing, Logistics, Distribution and Retail. Karyn has an MBA in e-commerce and was on the editorial board of the International Journal of e-commerce.

# Feature Article

***Q. What's the objective of the CILT International Convention?***

Our objective being to Bring Members together in order to have the opportunity to build their network of people who can raise one's calibre of work to greater heights as ideas, experiences and knowledge is shared from both the speakers and the delegates to achieve common individual and industry objectives.

To make this conference engaging, we have tried to create audience participation by building many panel discussions into most of the session segments. Leaving the audience with a sense of inclusion as you would with any networking event.

***Q. Please elaborate on the theme chosen for the CILT Convention?***

The theme "Automate, Integrate and Localise" was chosen as it represented where our industry needs to focus moving forward. It follows the statement: "On Demand

Logistics for the world of Tomorrow", again supporting the theme and the need to look forward to the future and not focus on the past. Our view is that we can't change the past but we can change the future.

***Q. Few words about the CILT Australia journey?***

CILT Australia has worked hard over the last few years focussing on the needs of our members and on tools that will take us into the future. Our focus has been on a much-needed upgrade of our technology, website and the introduction of a member engagement community platform. The work we are doing with some countries is proving a concept on enabling the International Business Forum using our technology. This is very exciting as we truly will break down the country borders by having this online engagement for our Corporate Members. Imagine having a global network of members, business owners and decision makers that can offer sound advice, share knowledge and open the door

to roadblocks in the supply chain. This will be possible as a result of the enablement, network, knowledge and experience of our Corporate Members and having this capability at your fingertips! What a truly futuristic approach to networking. This tool has an app so will travel with you wherever your job takes you. Ability to tap into this enabled network from wherever you have access to the mobile phone network or in front of your computer. Are we living the theme of the conference? Most truly!

***Q. What about your own career journey?***

I have a very diverse background that commenced in Retail in 1975 (part-time) whilst studying. In 1977 I began working for the Federal Health Department as a data processing operator but was not keen on doing this for the rest of my career. In 1979 I returned to retail as I loved the interaction with

customers and assisting them with their purchase. In 1981 I graduated from the retail management program and progressed from a department manager to a store manager.

In 1983 I had my first child, Jayde, a little girl with pale skin and red hair and an absolute perfect baby. Four years later 1987 I welcomed my son into the world. Both now have families of their own and I have four adorable grandchildren, 3 granddaughters and a grandson.



In 1989 I was challenged to take up the first casual role as a pushbike Postie for Australia Post. That was a very big difference to being a store manager. I had a young family at the time and saw this as an opportunity to work part-time and have time for them. Within 6 months of operating successfully in that role, an opportunity arose within retail (part-time) and I transferred to the role as

Postal Services Officer. Once in the role things became apparent that they (Australia Post) needed to change from a common counter to a retail outlet and become more focussed on ancillary services. Australia Post then pursued a retail course of bill payment and postage sales.

Coming from a strong retail background this transition was minimal for me and I soon became a counter supervisor and Postal Manager of various Post Offices. I was never one to hold back in coming forward when change needed to occur and after working in one of Melbourne's busiest post offices, I called a meeting with the then Area Manager to discuss not only our challenges but also possible solutions. After 1.5 hours the Area Manager stopped me and asked why I was in the role? I explained I progressed to this role from Postal Delivery. She said I have greater potential and offered another role as a Major Accounts manager in our Sales and Marketing.

In 1996 we underwent further changes and the offer was put to us all to further our education. I collaborated with 5 close associates and pursued higher education. At the completion of my studies Graduate Diploma in Business Management and MBA in eCommerce, I was transferred to Australia Post's recent subsidiary corProcure. corProcure was an aggregated purchasing platform for Australia's Corporates within the top 500. I managed the purchasing team and the aggregated purchasing agreements for these Stakeholders and the product offering of corProcure. This was Australia's first corporate online marketplace. Given my recent studies at university I understood the technology and its architecture and

the way it communicated. In my first two weeks in the role the technical team explained in detail how it all worked. At the end of it all a comment was made; "You really do understand how this all works don't you?"

Things changed, and I wrote Australia Post's first ever strategy for Legal Services. In 2010 there was a change in senior management at the highest level and the new MD made sweeping changes in HQ. These changes were significant and I took the opportunity to put my hand up to go. After the corProcure days I had lost my passion for Australia Post.

During this time I had been attending CILT Victoria's Committee meetings as an observer and in 2009 I joined CILT Australia after attending these meetings for about 8 months. I wanted to see if it was a good fit for me. I immediately became a Committee member of our Victorian Branch.

I took up some guest lectures with a major University in Melbourne around the same time and published some of my work in eCommerce. I contributed two chapters to an eCommerce Encyclopaedia and wrote two chapters to two other publications on eCommerce. Still the most popular of chapters read today.

After few other roles, in 2014 my ageing mother needed assistance so I stepped back from full-time work and commenced work with the Australia Bureau of Statistics as a Field Interviewer and worked from home. In 2016 I had a call to ask if I would be interested in the role with CILT Australia as the National Manager. I accepted the role but quickly took on more than what that role entailed and was promoted to the role of CEO.



*Q. How did WiLAT Australia come about?*

I established our WiLAT section in 2017 and more recently our Next Generation seeing the need to align with other branches globally. We had Peta Irving as our convenor initially and now Catherine Lou as the Chair of WiLAT in Australia. Vivian Chen is also the Chair of Next Generation for CILT Australia. I have since worked tirelessly re-establishing CILT Australia from where it was in the past to a vibrant exciting place to be for the future.



*Q. Few words on the lead up to the CILT International Conference and overcoming the COVID-19 challenge?*

In 2018 we put in our bid for the 2020 CILT International Conference and began preparing for the conference activities in late 2019. COVID hit in 2020 and this meant significant change was needed to occur and immediately if we were to continue. We discussed many things in regard to the conference given lockdowns

and restrictions and after having a discussion with the Secretary General decided to postpone until 2021 and review at the beginning of that year.

In 2021 things had not improved in regards to COVID and at that time border restrictions were in place. Having our international brothers and sisters visit Perth was not going to be possible so we decided to postpone for a further year. Over this time had become quite familiar with using Zoom and had started to do online networking via break-out rooms. This all became possible after I connected with a network called the Connect Collaborative who provided me with the knowledge and access to technologies needed for today but previously unexplored.

The Connect Collaborative also showed us tools within LinkedIn that may assist in finding Sponsors for the Conference utilising the tool of LinkedIn Helper. We were successful in identifying 2 sponsors using this method and connecting with many others on LinkedIn.

The National Council wanted to apply a very different model to the CILT International Conference and bring in well known industry professionals to discuss industry topics with our audience where we could all learn from each other across the globe. In the past it had been focused on CILT centric activities with the odd one or two guest speakers. We had become known as the silver hair club and our thinking was considered old school and this needed change if we are to be attractive to a younger audience of the future. We utilised young talent as interns, to assist in the preparation of engaging promo material.

COVID's impact on our Institute made it very obvious that we needed to

change the way we operate and re-engage with our members in a very different way and so I searched for platforms and strategies that addressed this challenge. After meeting with Minter Ellison, I was able to refine the strategy and took it to the National Council for endorsement. It took us a further 10 months to identify the right technology at the right price to move forward. In October 2021 we launched our platform and had an immediate engagement with our members. Without the endorsement of the National Council we could not have proceeded to the point where we are today.

All these initiatives have led to our renewals this year to hit a record-breaking 78%. Redeeming the benefits of some hard work over the last few years through more engaging initiatives. Our members have been very patient over our recent changes and have commented on the change in CILT Australia in a very positive way. I'd like to think I played a big part in that over the 2019 - 2022 period. This year will see further changes and enhancements to our platform as we implement our Marketing module and Member Management module due to be completed by October 2022. Most of our offices will be automated as a result. This will free up time to be out and about seeking opportunities to grow further as the need arises.

CILT Australia looks forward to meeting the global members in person at the much awaited CILT International Convention in Perth, at Hyatt Regency on 23rd October 2022.

### *A Technology to Reduce Methane Slip in Maritime LNG*

India's Kolkata Port, recently renamed Syama Prasad Mookerjee and has performed the last of four pilot sailings to move domestic cargo to the north-eastern corridor via Chittagong and Mongla in Bangladesh, to encourage the use of waterways as an alternative to trucking. This multimodal arrangement was drawn up under a government-to-government agreement reached in March between Dhaka and New Delhi, advancing the scope of the bilateral "inland water transit and trade protocol".
