



Next Generation – Nominations for Global Chair and Deputy Global Chair

Background notes for candidates

- Chaired by the Global Chairperson and members, it comprises the Deputy Global Chairperson and Regional Chairpersons, form the Next Generation Steering Committee
- Regions are: Africa, Americas, Australasia, Central Asia and Middle East, East Asia, Europe and UK, South Asia and South East Asia
- The Committee members have a tenure of 3 years, potentially extendable twice by 1 + 1 year, for a maximum of 5 years

The Next Generation Forum is led by a chairperson who presides over the Steering Committee and acts as the primary representative of the Next Generation Forum within CILT International. The chairperson represents the interests of Next Generation members and is responsible for setting the agenda, coordinating activities, and ensuring effective communication between regions, countries and CILT International.

The Deputy Global Chairperson supports the Global Chairperson and assumes their responsibilities in Global Chairperson's absence. The incumbent is responsible for the administration of the forum and acts in line with the guidance from the Global Chairperson. They work together to further Next Generation's global initiatives and projects in accordance with the Next Generation's operational guidelines.

The Global Chairperson and Deputy must be from two different regions.

Person specification Chair/Deputy

- Has at least two years' work experience in either the supply chain, transport and/or logistics industry
- Has carried out country or global Next Generation responsibilities in some form
- Has received a written recommendation from the Next Generation executive committee of their country for their nomination
- Has a written recommendation of the National Council or Board of their CILT Branch/Territory
- Proactive and able to drive a global agenda across cultures and nationalities
- Good communicator and listener
- Able to allocate time for CILT Next Generation matters during a typical week.
- Has the time and ability to represent the Next Generation at meetings, which may include, but not limited to the Council of Trustees (CoT); International Management Committee (IMC); International Conventions and Regional Forums
- Has support of the National Council or Board of their CILT Branch/Territory to perform the role effectively – use of time, and recognition of development opportunity



Next Generation – Nominations for Global Chair and Deputy Global Chair

- Has the support of their employer to effectively perform the role, including time allocation and recognition of the development opportunity
- Has a demonstrated track record of teamwork and delivery of CILT initiatives and actions
- Able to facilitate and lead group sessions and present to groups of members

Eligibility Criteria

- Aged 35 or under
- Have held Affiliate or Non-Chartered Membership for five years or less

- The International Secretariat makes applications anonymous and then forwards to the Next Generational Forum Committee by 31st July 2025
- The Next Generation Forum Committee makes recommendations to the IMC of the selected Global Chairperson and Deputy Global Chairperson by confirming their choice to Jan Steenberg, Chair of IMC
