SUBJECT: CILT NIGERIA REPORT TO IMC FOR NOVEMBER 29, 2017 MEETING Please find herewith the report of the activities of CILT Nigeria for your attention.

1. Industry programmes Participation

- i. CILT Nigeria presented a position at a workshop organised by the Independent National Electoral Commission on "Improving Election Logistics in Nigeria." It was sponsored by the European Union ahead of the 2019 General Elections in Nigeria
- ii. As part of our capacity building initiative, a workshop with the theme, 'Building Capacity for Effective Ports State Control' was held in September 2018 in the Eastern part of the country. Similarly, we held series of Mandatory Professional Development (MPD) programmes in the Southern and Northern part s of Nigeria. A Mandatory Development Programme of the Institute was held in Abuja for Members, in the Northern parts of the country. This was in early October, 2018. The Institute participated at the Nigerian Air Force National Conference on "Effective Logistics and Procurement Support."

2. Education

- i. The accreditation of the University of Port Harcourt was done on October 15, 2018 with the National Deputy President leading the team. The University faculty, learning facilities, environment, etc, are adequate for students. The university is prepared to run the International Diploma and Advanced Diploma programmes.
- ii. The Professional Diploma programme in Pharmaceutical Logistics, being worked out between CILT Nigeria and Multi-Mix Academy is ongoing and when action is concluded by CILT Nigeria, same will be sent to CILT International for purposes of consideration and adoption.

- iii. A relationship with the Nigeria Air Force has been initiated with the aim of assessing their curriculum and thereafter inject MDP programme to enable the officers of the Force have access to the different grades of membership.
- iv. CILT professional examinations will hold from November 21st to 23rd 2018 at the designated centres in Nigeria.

3. National Conference and Annual General Meeting (AGM)

- i. The above programmes were held at the Golden Tulip Hotel on October 26-27, 2018 in Lagos. Over 350 delegates attended. The theme of the conference was Trucks in Freight Logistics System: Issues in Nigeria Economic Development. The National Conference also witnessed the conferment of Fellow's Grade on deserving members including the induction of Member, Chartered member grades and Graduating Professional Students.
- ii. A formal Annual Report of activities/Annual Audited Account were presented to members on October 27th and members at the AGM.
- **4.** Election for all officers of Council was held under a peaceful atmosphere with the National President, and National Deputy President Messer. Ibrahim A. Jibril and Alban Igwe including Road Mode and Female representatives were returned unopposed due to their excellent performances. Two Vice Presidents, Rail and maritime Modal Representatives, Oil and Gas, and Logistics Representatives were elected at the floor of the AGM. The elections were rancour free.

Upcoming Programme

As a way of ending the year on a bright note CILT Nigeria is set to hold the following programmes: Recognition/merit awards on deserving industry captains and Industry Leadership Lecture.
