MINUTES OF THE ANNUAL GENERAL MEETING 2017

Minutes of the Annual General Meeting of **The Chartered Institute of Logistics and Transport in Hong Kong** (the Institute) held on 14th September 2017 at 1905 hours in the Function Rooms, 3rd Floor, South Tower, "The Salisbury" – YMCA of Hong Kong, 41 Salisbury Road, Tsimshatsui, Kowloon, Hong Kong.

There being a quorum, the meeting proceeded to business. Mr. TSANG Wing-hang, FCILT, President, took the chair.

1 Welcome address by the Chairperson

The Chairperson welcomed members, Mr. Ronald LEE representing Ronald H.T. Lee & Co, Honorary Auditor, and guests to the Annual General Meeting 2017.

2 Notice of Meeting

The Chairperson noted that the Notice convening the Meeting had been served to members for the prescribed period. The Notice was taken as read.

3 Receipt of Proxy Forms

The Chairperson reported that one (1) Proxy Form had been received from a Chartered Fellow (Mr. Mark MILLAR) in authorising the Chairperson of the meeting, i.e. the President, to be his proxy to vote on his behalf.

The following resolutions were passed:

To receive and adopt the minutes of the AGM 2016 held on 20th September 2016
There being no other amendments, the minutes were confirmed. The motion was proposed by Mr. Sunny Lap-kee HO, FCILT, and seconded by Ms. Carolina Lai-ching YIP, FCILT. The meeting adopted the minutes of AGM 2016 as a true and correct record.

5 To receive and adopt 2016/2017 Annual Report of the Council

The meeting received and noted the Annual Report for the year 2016/2017. The Chairperson described highlights in the President's Report as follows:



- a 2.4% increase in terms of membership number in 2016/2017 over the previous year and the Institute would continue the works in membership growth by attracting professionals to be our members and in particular recruiting Organisation Members;
- award presentation ceremony would be conducted in the later session of the AGM including the CILTHK President Award 2017 to Prof. Becky pui-ying LOO, FCILT; and the CILTHK Young Achiever Award 2017 to Mr. Gary Xin-yu ZHANG;
- the Institute continued participating in CILT International affairs/events actively and members were encouraged to participate in two forthcoming events in China in 2017 and Poland in 2018;
- the Institute had been active in promoting public awareness of the Institute by means of organising various CPD activities, academic competitions and industrial competition;
- to attract potential Student Members, introduction of our profession and Institute had been given to freshmen on their Orientation Days; and a new incentive scheme to give a total free Student Membership would be presented in the AGM agenda later;
- 10 submissions of position papers to government bureau/departments had been prepared last year; one of them was an attempt for an inclusion of CILTHK members as individual electors in the Transport Functional Constituency;
- CALF, a training programme, was continued in enhancing young professionals' skill and competency as well as to broaden their networks with experienced executives in the industry.

In concluding the President's Report, Mr. TSANG conveyed his appreciations to the Council Members, committee members, volunteer members and sponsors and working partners for the support and works in the past year.

There were no questions or enquiries raised by members in relation to the committee reports. The meeting confirmed the adoption of the Annual Report 2016/2017. The motion was proposed by Ir Prof. WONG Sze-chun, FCILT, and seconded by Dr. Venus Yuen-ha LUN, FCILT.

To receive and adopt the Institute's Financial Report for the year ending 31st December 2016

The Honorary Treasurer, Dr. Kenneth Kam-hung PANG, FCILT, reported that an operating surplus of HK\$93,564 was recorded in 2016 in comparing with a deficit of HK\$6,964 in 2015. At the year end in 2016, both the Institute's net assets and cash equivalents were higher than the year before, the Institute had been maintaining a healthy financial position.

Mr. Peter Yee-chun NG, FCILT, proposed that the Accounts be accepted. The motion was seconded by Mr. William Chak-man CHUNG, CMILT, and Ms. Alice Wai-chong YIP, CMILT, and endorsed by members.

7 To consider and pass a Special Resolution on the Adjustment of the Certification Fee for students undertaking CILTHK accredited programmes with effect from 1st October 2017 (Appendix II)

The Chairperson reported a relatively low figure of new membership received from students undertaking CILTHK accredited programmes in 2015/2016 which was 61 vs the total number of students of 2,826. On top of the current incentive schemes for current students, a new initiative by the Quality Assurance Committee was presented in giving a waiver of membership application fee which was HK\$150 to all eligible



students in attracting their application for CILTHK membership.

There were no enquiries or questions raised by members. 41 votes by Institute Members were recorded in the meeting (i.e. 98% of the eligible votes). The motion on the adjustment of the Certification Fee for students undertaking CILTHK accredited programmes with effect from 1st October 2017 was approved and adopted.

8 To consider and pass Special resolution on the alteration of the Institute's Articles of Association (Appendix III)

The Chairperson explained the motion was in fact passed in the last AGM; however, due to subsequent comments received from the Inland Revenue Department after the AGM and therefore the resolution passed became ineffective as advised by the Companies Registry. The revised Articles of Association therefore had to re-present again for members' adoption.

There were no enquiries or questions raised by members. It was supported by 37 votes by Institute Members (i.e. 88% of the eligible votes). The motion to adopt the alteration of the Institute's Articles of Association was approved.

9 To re-appoint Ronald H.T. Lee & Co. as the Honorary Auditor to audit the account for the financial year ending 31st December 2017

Ir Dr. David Chi-shing HO, FCILT, proposed, and seconded by both Mr. Sunny Lap-kee HO, FCILT, and Ms. Carolina Lai-ching YIP, FCILT, and the meeting endorsed the re-appointment of Ronald H.T. Lee & Co. as the Honorary Auditor for the financial year ended 31st December 2017.

10.2 CILTHK President Award 2017:

Prof. Becky Pui-ying LOO, FCILT, was conferred with this prestigious award.

 Prof. LOO was the President of the Institute in 2012-2014, International Vice President in 2012-2016 and had been chairing the International Membership Standards Committee till 2017. In appreciation of her long-service and distinguished contributions to the Institute, the industry and the community, Prof. LOO was conferred with the CILTHK President Award 2017.

10.3 CILTHK Young Achiever Award 2017

Mr. Gary Xin-yu ZHANG was selected as the CILTHK Young Achiever 2017.

 Gary had been working at MTR after graduation in 2011 and currently was the Group Station Manager overseeing the operations of the Kwun Tong Line and Tsuen Wan Line. During his job assignments in MTR, he had been involved in various railway projects in Hong Kong and Hangzhou. Gary dedicated himself to



people development to mentor the young Graduate Engineers and Railway Operations Trainees.

10.4 CILTHK Scholarships 2016/2017:

The Institute would like to express our heartfelt thanks to Airport Authority Hong Kong for their donation of the scholarship fund.

One awardee for each academic level was selected by the Judging Panel. The awards were presented by Mr. TSANG Wing-hang, FCILT, to the following students:

- Sub-degree level student: Mr. WONG Chik-ho of HKU SPACE Community College (HD in Logistics and Transport);
- Bachelor degree student: Miss LIANG Wenshan, Iris, of The Hong Kong Polytechnic University (BSc (Hons) in Logistics Engineering with Management);
- Master degree student: Mr. DANG Xinlong of The Hong Kong Polytechnic University (MSc in International Shipping and Transport Logistics) [Mr. DANG was unable to attend the award presentation as he was on a business trip in Shanghai.]

10.5 <u>CILTHK Kerry Logistics Scholarship 2016/2017</u>

Kerry Warehouse (HK) Limited sponsored this new titled scholarship for a term of 3 years 2016-2019. Participating students were required to attend a technical visit at Kerry Logistics PC³ warehouse in Tai Po and then to prepare a presentation on the topic - *The importance of process flow in logistics industry*.

Three awards were presented to one master degree student and two bachelor degree students undertaking CILTHK accredited logistics programmes. The awards were presented by Mr. TSANG Wing-hang, FCILT, and Mr. Alan CHEUNG, Executive Director of Kerry Logistics, to the following students:

- Master degree student: Miss LAU Suet-ying, Alice, of The Hong Kong Polytechnic University (MSc in International Shipping and Transport Logistics);
- 1st Bachelor degree student: Miss TSE Yan-wing of Hang Seng Management College (BBA in Supply Chain Management (Hons));
- 2nd Bachelor degree student: Mr. WONG Chi-kit of The Hong Kong Polytechnic University (BSc (Hons) in Logistics Engineering with Management).

10.6 <u>CILTHK Logistics & Transport Student Final Year Project Award 2017</u>

The objective of the award is to encourage research and writing by students. A total of 8 nominations were received. The Award was sponsored by Airport Authority Hong Kong.

The award was presented by Mr. TSANG Wing-hang, FCILT, to Miss HO Wing-hang, a graduate of BSc (Hons) in Logistics Engineering with Management from The Hong Kong Polytechnic University. Her winning project title was "Design of a follow up treatment scheduling system for optimising the routing of home care nursing staff in the healthcare industry".

10.7 CILTHK Youth Project 2017

The competition was to replace the past's Case Competition. A shortlisted six teams and each had been assigned to take up a real-life case study in a local company. The Young Members Committee (YMC) would like to take this opportunity to thank once again the six companies being Citybus, DHL, Hong Kong Ferry, KMB, Kerry Logistics and MTR in supporting this competition and giving guidance to participating students. The prize for the winning team was two ground theory training at Hong



Kong Aviation Club sponsored by Ir Dr. Paul Hon-yan TSUI, FCILT, Chairperson of YMC.

The winning team went to Miss TANG Yan-man, Peggy and Miss WONG Lok-ting, Angel from the MSc in Urban Planning of The University of Hong Kong whose study was in relation to Citybus on "The Impacts of Traffic Congestion on Bus Service Quality & Bus Passenger Loyalty in a Competing Operating Environment: a Case Study of 592 Bus Route" [Both students were unable to attend the award presentation ceremony due to a crash with class schedule].

PRESIDENT'S REPORT

By Mr. TSANG Wing-hang, FCILT President

On behalf of the Council of the Chartered Institute of Logistics and Transport in Hong Kong (CILTHK), I hereby present the Council Report for the year 2017/2018.

In 1968, the Chartered Institute of Logistics and Transport set up its branch in Hong Kong. Since then, the Institute has grown from strength to strength. We were upgraded to become a Hong Kong Section in 1972 and further upgraded to the 'National Council' status in 1991. In 2018, events/activities are organised throughout the year to mark the 50th anniversary of the establishment of the Institute.

HIGHLIGHTS OF THE YEAR

Membership

There were a total of 367 successful new membership applications in the past year representing an increase of 9.76% (+2.4% in 2016/2017). The membership now stands at 1,956. With the Free Student Membership approved in last year's Annual General Meeting, there was an increase of 271 Student Members. The incentive scheme has attracted around 12% of full-time students undertaking CILTHK accredited programmes to join the Institute. We are going to work more closely with programme leaders to attract students to become members to keep the Institute growing. On the other hand, member retention is critical to our long-term success. In this connection, we will put more efforts for creating more membership values and getting members involved in Institute activities and affairs, etc. so to enhancing the bonding between members and the Institute.

- Talented and well-established professionals will be identified for nomination as Chartered Fellows.
- Potential Members (MILTs) are encouraged to apply for upgrading their membership to Chartered Membership.
- Application process for free Student Membership will be further simplified to facilitate applications.

The Hon. Frankie Chi-ming YICK, FCILT, has been conferred with the CILTHK President Award 2018 by the Council. With extensive knowledge and experience, Mr. YICK, has been serving the Council and various committees since 2006. In addition, he has been a Legislative Councillor since in 2012 representing the Transport Constituency and contributing towards the transport & logistics industry and the community. Mr. YICK will be presented the Award in AGM 2018.

Mr. Paul Lik-hang LEE has been elected as the CILTHK Young Achiever 2018. Mr. LEE pursuits his personal goal as an entrepreneur and founded a technology company focusing on AR and VR. His clear personal vision and self-motivation helped him-to be conferred with the CILTHK Young Achiever 2018.

Finance

I am pleased to report again the attainment of an operational surplus of HK\$43,798 for the period from 1st January 2017 to 31st December 2017 (surplus in Year 2016: HK\$93,564), after depreciation. As at 31st December 2017, the Institute recorded an increase in net assets which amounted to \$6,652,817 (Year 2016: \$6,545,019). Likewise, the cash balance also increased to \$5,008,259 (Year 2016: \$4,893,153), both including funds held on behalf of Government Grants.

The Institute's incomes and expenses are closely monitored thus resulting in a healthy financial position. To this end, I must express my and the Institute's sincere appreciation to the generous and continuous support of Institute activities by members and organisations concerned

Celebration of the 50th Anniversary

As mentioned at the beginning of this President Report, 2018 is a milestone year for CILTHK. To commemorate the Golden Jubilee, key events/activities are organised as follows:

- Anniversary newspaper supplements Evolution of Transport & Logistics in Hong Kong for 50 years, on Ming Pao and The Standard on 5th June 2018
- CILTHK 50th Anniversary Gala Dinner on 22nd June 2018
- International Conference on Smart Mobility and Logistics in Future Cities co-organised with the Institute of Transport Studies, HKU and the Transport Department in HKCEC from 18th to 20th October 2018
- 50th Anniversary Seminar Series reviewing the development of selected sectors in transport / logistics in different seminars from May to November 2018

Relationship with CILT International

Similar to the past, CILTHK has continued to support the international affairs of the CILT International in International Management Committee, Women in Logistics and Transport, Young Professionals and act as an International Secretariat on membership administration (Institute Branches). Institute representatives were supported to attend international and



regional convention/conferences in past year (please refer to details in the SC Report on pp29-30 and WiLAT HK Report on pp71-74).

At the same time, CILT International also supports CILTHK by the following activities:

- Lt Col (Ret) Kevin BYRNE, International President, joined the CILTHK 50th Anniversary Gala Dinner 2018
- Mr. Keith NEWTON, Secretary General, will join the International Conference on Smart Mobility and Logistics in Future Cities and serve as a key note speaker

Taking this opportunity, I would like to inform members that CILT International will hold the Centennial Celebration (1919-2019) in Manchester on 16th-18th June 2019 (https://ciltuk.org.uk/Conference2019).

Professional Development for members

Among our important tasks, the Institute is obliged to help human capital development in the transport and logistics field. On a regular basis, the Institute convenes professional development activities such as technical seminars and visits to broaden our members' knowledge, experience and exposure.

In addition, collaborations with other recognised professional institutes/organisations including HKU-ITS, PolyU-Shipping Research Centre, HKU SPACE Centre for Logistics and Transport, SCLP, BSL, GS1 Hong Kong, HKAC, HKARMS, HKIA, HKIE/HKIE-LTD, HKILA, HKIUD, HKIP, HKIS, HKSTLA, HKTDC, IOSH(HK), IMechE, LSCM, etc. are continued through co-organising/supporting different seminars, conferences, workshops.

Promoting Public Awareness

The annual Essay Competition and Student Day were successfully held with support by the University of Hong Kong on 10th March 2018. A full report on both events was published, with a full page newspaper supplement in Ming Pao on 27th March 2018, and in CILTHK Newsletter Issue 72.

The CILT Award 2017 "Service Excellence" were awarded to two distinguished companies, the DKSH Hong Kong Limited and the Worldwide Cruise Terminals. To mark their success, special interviews with their senior management team were published alongside the Institute's Anniversary newspaper supplements on 5th June 2018.

For more efficient distribution and circulation, the Institute's quarterly newsletters have changed to be published in the form of eNewsletter from Issue 72 (1st publication in 2018). The same practice has also extended to the publication of Ince & Co. - CILTHK Logistics Newsletters. Members are encouraged to share the newsletters with friends and associates to arouse their interests in the Institute.



Submissions and Public Service

One of the objectives of the Institute is to serve for the betterment of the community. Among other contributions, the Institute has been offering timely professional views and advices to the Government on different transport and logistics matters in Hong Kong.

- Policy Address 2018, 20th August 2018 to Policy Innovation and Co-ordination Office
- Views on Public Engagement re Land for Hong Kong: Our Home, Our Say! 29th August 2018 to the Secretariat, Task Force on Land Supply

- Three CILTHK Scholarships for each level of master degree, bachelor degree and sub-degree level will be presented at the AGM 2018 (E&T report pp37-38)
- The second CILTHK Kerry Logistics Scholarship will be presented to 3 logistics students at the AGM 2018 (E&T report p38)
- The CILTHK Pitch Competition 2018 organised by YMC was won by students of The Hong Kong University of Science and Technology (YMC report p76).

The second Career and the Life Formula (CALF) Professional Advancement Programme for Young Managers of the Logistics & Transport Industry was completed in November last year (E&T report p39 & WiLAT report p70). The new term will soon be commenced with a theme on One Belt One Road and Greater Bay Area.

In the International Convention 2018 held in last June, our young member, Ir Gary ZHANG, CILTHK's Young Achiever awardee, was elected as the International Young Achiever of the year. We are proud of the outcome as this is the second time the International Young Achiever being awarded to CILTHK members in a row.

HONORARY TREASURER'S REPORT

1. GENERAL

This paper provides an overview on the financial status of the Institute for the year ended 31st December 2017.

2. FINANCIAL STATUS REVIEW

The Audited Accounts for the year ending 31st December 2017 have been examined with the following highlights.

2.1 **2017 Results**

The Institute recorded an operating surplus of \$43,798 in 2017 (Year 2016: a surplus of \$93,564).

2.2 Balance Sheet

As at 31st December 2017, the Institute recorded net assets of \$6,652,817 (Year 2016: \$6,545,019). Cash and the cash equivalents as at the balance sheet date recorded at \$5.01M (Year 2016: \$4.89M) including funds held on behalf of WiLAT and Government Grant.

3. REVIEW OF THE YEAR

Notwithstanding the above, we are pleased that the Institute, as a non-profit organisation, continued to maintain a fair and healthy financial position.

4. LOOKING AHEAD

The Finance Committee will closely monitor the Institute's financial situation and work with respective committee chairs on maintaining costs within the budget.

Independent Auditor's Report to the Members of The Chartered Institute of Logistics and Transport in Hong Kong (Incorporated in Hong Kong and limited by guarantee)

Opinion

We have audited the financial statements of The Chartered Institute of Logistics and Transport in Hong Kong (the "Institute") set out on pages 18 to 28, which comprise the statement of financial position as at 31 December 2017, and the income statement and statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the financial statements of the Institute are prepared, in all material respects, in accordance with the Hong Kong Small and Medium-sized Entity Financial Reporting Standard ("SME-FRS") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and have been properly prepared in compliance with the Hong Kong Companies Ordinance.

Basis for Opinion

We conducted our audit in accordance with Hong Kong Standards on Auditing ("HKSAs") and with reference to Practice Note 900 (Revised), *Audit of Financial Statements Prepared in Accordance with the Small and Medium-sized Entity Financial Reporting Standard* issued by the HKICPA. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are independent of the Institute in accordance with the HKICPA's *Code of Ethics for Professional Accountants* ("the Code"), and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Other Information

The Council Members are responsible for the other information. The other information comprises the information included in the President's Report and Honorary Treasurer's Report, but does not include the financial statements and our auditor's report thereon.

Our opinion on the financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. This report is made solely to you, as a body, in accordance with Section 405 of the Hong Kong Companies Ordinance, and for no other purpose. We do not assume responsibility towards or accept liability to any other person for the contents of this report. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with HKSAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with HKSAs, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. Reporting Entity

The Chartered Institute of Logistics and Transport in Hong Kong (the "Institute") is a body corporate incorporated in Hong Kong as an institute limited by guarantee. The Institute's registered office is located at 7/F., Yue Hing Building, 103 Hennessy Road, Wanchai, Hong Kong. The principal activities of the Institute include, inter alia, to promote, encourage and co-ordinate the study of the science and art of transport; to initiate, foster and maintain investigation and research into the best means and methods of any appliances for transport, transit and locomotion and the problems that are involved and their most satisfactory solution; to extend, increase and disseminate knowledge and exchange information and ideas in regard to all questions connected therewith; and to assist and further in all practicable ways the development and improvement of transport, transit and locomotion in the best interest of the community. The liability of the members is limited to contributing to the assets of the Institute to the extent of HK\$10 each in the event that the Institute is wound up.

1. Basis of Preparation and Accounting Policies

The Institute qualifies for the reporting exemption as a small guarantee company under Section 359(1)(a) of the Hong Kong Companies Ordinance (Cap. 622) and is therefore entitled to prepare and present its financial statements in accordance with the Small and Medium-sized Entity Financial Reporting Standard (SME-FRS) issued by the Hong Kong Institute of Certified Public Accountants.

These financial statements comply with the SME-FRS and have been prepared under the accrual basis of accounting and on the basis that the Institute is a going concern.

The measurement base adopted is the historical cost convention.

The following are the specific accounting policies that are necessary for a proper understanding of the financial statements:

a). Revenue Recognition

Revenue is recognised when it is probable that the economic benefits will flow to the Institute and when the revenue can be measured reliably, on the following bases:

- (i) Members' subscription fees are recognised on a time proportion basis.
- (ii) Accreditation income, administrative income and income from examinations are recognized at a point in time on completion of services.
- (iii) Interest income is recognised on a time proportion basis taking into account the principal outstanding and at the interest rate applicable.
- (iv) Members' entrance fees are recognized at a point in time on completion of assessment services by granting the qualification and status to the applicants.

a). Revenue Recognition (Cont'd)

(v) Revenue from activities is recognised upon completion of the relevant events.

b).Borrowing Costs

Borrowing costs are recognised as an expense in the period in which they are incurred.

c). Foreign Exchange

The reporting currency of the Institute is Hong Kong Dollars, which is the currency of the primary economic environment in which the Institute operates.

Foreign currency transactions are converted at the exchange rates applicable at the transaction dates. Foreign currency monetary items are translated into Hong Kong Dollars using exchange rates applicable at the end of the reporting period. Gains and losses on foreign exchange are recognised in the income statement.

d). Property, Plant and Equipment

Property, plant and equipment are stated at cost less accumulated depreciation and impairment losses, if any.

The depreciable amount of an item of property, plant and equipment is allocated on a systematic basis over its estimated useful life using the straight-line method. The principal annual rates used for depreciation are as follows:

Leasehold land Over the remaining lease term

Buildings 2.5% Leasehold improvements 20% Furniture and equipment 20%

e).Impairment of Assets

An assessment is made at the end of each reporting period to determine whether there is any indication of impairment or reversal of previous impairment, including terms of property, plant and equipment. In the event that an asset's carrying amount exceeds its recoverable amount, the carrying amount is reduced to recoverable amount and an impairment loss is recognise in the income statement. A previously recognised impairment loss is reversed only if there has been a change in estimates used to determine the recoverable amount, however not to an amount higher than the carrying amount that would have been determined (net of depreciation), had no impairment losses been recognised for the asset in prior years.

f). Accounts and Other Receivables

Accounts and other receivables are stated at estimated realisable value after each debt has been considered individually. Where the payment of a debt becomes doubtful a provision is made and charged to the income statement.

g).Retirement Benefit Costs

The Institute participates in a Mandatory Provident Fund Scheme (the MPF scheme) under the Hong Kong Mandatory Provident Fund Schemes Ordinance for employees employed under the jurisdiction of the Hong Kong Employment Ordinance and not previously covered by the defined benefit retirement plan. The MPF scheme is a defined contribution retirement plan administered by independent trustees. Under the MPF scheme, the employer and its employees are each required to make contributions to the plan at 5% of the employees' relevant income, subject to a cap of monthly relevant income of HK\$30,000. Contributions to the plan vest immediately.

h).Leases

Leases that transfer substantially all the rewards and risks of ownership of assets to the Institute are accounted for as finance leases. At the inception of a finance lease, the cost of the leased asset is capitalised at the fair value of the leased asset or, if lower, at the present value of the minimum lease payments. Lease payments are apportioned between the finance charges and reduction of the lease liability so as to achieve a constant rate of interest on the remaining balance of the liability. Finance charges are charged to the income statement.

Capitalised leased assets are depreciated over the shorter of the estimated useful life of the asset or the lease term.

Leases where substantially all the risks and rewards of ownership of assets are not transferred to the lessee are accounted for as operating leases. Annual rents applicable to such operating leases are charged to the income statement on a straight-line basis over the lease term.

i). Government Grant

A government grant is not recognised until there is reasonable assurance that the entity will comply with the conditions attaching to it, and that the grant will be received. Receipt of a grant does not of itself provide conclusive evidence that the conditions attaching to the grant have been or will be fulfilled.

j). Cash and Cash Equivalents

Cash and cash equivalents comprise cash at bank and on hand and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value. Bank overdrafts that are repayable on demand and form an integral part of the Institute's cash management are also included as a component of cash and cash equivalents for the purpose of the cash flow statement.

2. Revenue

Revenue represents members' subscription fees.

Revamp of the Institute website

- 3. To improve the working efficiency, enrich the functionality of the Institute website to have closer communication with members and public, the revamp of the Institute website has been commenced. The selection of service provider has been completed with the task awarded to Elogi Systems Limited.
- 4. The exercise will be commenced in the 4th quarter of 2018 and will take about 6 months. As reported in last year's report, the work scope will be as follows:
 - re-design the artistic outlook of web pages, to re-organise functions and to modify it to be a mobile-friendly website
 - plus enhancement of the current event management system and CPD recording system

Drafting of Institute's Entertainment Policy

5. To ensure that the Institute maintains appropriate oversight and governance over the approvals, reporting and controls relating to expenditure of the Institute's funds, an 'Entertainment Policy' has been drafted and will seek for the Council's approval in the first meeting in the coming new session.

Review of Annual Membership Fee

- 6. To ensure the financial sustainability of the Institute, a review of the annual membership fee has been conducted once every two years that any adjustment would be subject to the inflation rate and the financial status of the Institute.
- 7. The annual subscription is the main source of income for the Institute; however, the estimated incomes in the next two years would hardly cover the expenditures. In line with the policy of "small and often" fee adjustment, different membership fee adjustment scenarios for implementation in 2020 are being worked out for the Council's consideration.



EU's General Data Protection Regulation (GDPR)

- 8. The GDPR is a regulation in EU law on data protection and privacy for all individuals within the European Union (EU) and the European Economic Area (EEA). It has come into force on 25th May 2018.
- 9. There are some CILTHK members who are EU citizens and therefore legal advice had been sought from our Hon. Legal Advisor on the collection and retention of personal data. The legal advice was the GDPR would not apply to the Institute and therefore we only need to comply with the local Personal Data (Privacy) Ordinance in handling members' personal information.

CILT International Membership Administration

- CILTHK has been commissioned by CILT International for assessing and administering membership applications for FCILT/CMILT/MILT/Affiliate from CILT Institute Branches worldwide since 1st July 2008.
- 11. An Assessment Panel formed by at least 3 FCILTs and/or CMILTs met every two months. Special thanks are extended to Mr. LEUNG Kong-yui, FCILT and Chairman of the Membership Committee (MC), and members of MC for taking up the assessment jobs since October 2012. - 16. 2 Briefing Sessions on the CPD Audit 2018 for assisting members in better preparing for the audit were held on 23rd November 2017 and 28th June 2018 in CILTHK Office respectively.



17. The cycle of CPD Audit 2018 was from 1st January 2016 to 31st July 2018 and a minimum of 200 CPD points is required. Members were selected randomly and required to provide their reports with documentary evidence on their attendance or completion of CPD activities. Mr. LUI Shu-tim, CMILT, had achieved the highest score of a total of 1,360 CPD points and has been selected for the CPD Award. The award will be presented at AGM 2018 in recognising his achievement.

CILTHK/ HAFFA Joint Program - Training Programme for the Freight Logistics Sector

- 18. After years of effort and a re-structure of the programme in the last two years, the overall enrolment fell short of expectation. On the other hand, there is no lack of means for industry practitioners to enhance their knowledge and skills with various courses in logistics in the market. - 19. CILTHK and HAFFA will keep in view of the development and training needs of industry practitioners, as well as the changing trends and directions of the logistics industry. As and when new training needs appear, CILTHK and HAFFA will consider the need to develop new programmes for the industry

Career and Life Formula (CALF) Professional Advancement Programme for Young Managers of the Logistics & Transport Industry

- 20. The second year's CALF programme was completed in November 2017. 14 participants, out of 20, were satisfactorily completed the programme. Each of them was presented with the certificate by the President at the Graduation Ceremony on 27th August 2018. They have also been paired up for a free executive coaching service for one year.

The Institute tendered the comments on the situation and offered proposal for the ways in which the Government can assist.

To celebrate the 50th Anniversary of CILTHK in 2018, PAC joins force with MPC to organise the CILTHK 50th Anniversary Seminar Series – **Evolution of Transport and Logistics in Hong Kong for 50 years** to illustrate and appraise the development of the transport and logistics industries in Hong Kong. Renowned local transport and logistics companies which have more than 50 years of history have been invited to share their stories. The first two seminars were held successfully in May and July.



"Episode I: Train & Tram" presented by Hong Kong Tramways Ltd. (HKT) and MTR Corporation Ltd. (MTR) on 26th May 2018

HKT is regarded as one of the busiest tram lines in the world. The tramway serves up to 200,000 passengers per day. Paralleling the modernisation of facilities and enhancement of service quality, retaining the over 100-year icon is always their mission. Mr. Cyril AUBIN, Managing Director of HKT and Mr. Steven CHAN, the Senior Engineering Manager shared the story of the 100-year iconic double-decker from the past to present and addressed how HKT strives to provide environmental friendly local public transport services at high frequency and low prices.

MTR established in 1975 to provide mass transit service for Hong Kong people, it has evolved from a single-line operation to an integrated network covering all districts of Hong Kong. The passenger capacity is now about 5.8 million passengers per day which covers nearly 50 percent of the travelling public. Mr. Ronnie TONG, Head of Operating; Mr. Kelson CHAN, Strategy & Planning Manager and Ir Gary ZHANG, Group Station Manager of MTR, elaborated to audience how MTR adopts a customer-centric strategy and adopts innovation and technology to tackle the many technical, commercial and societal challenges, at the same time shared how MTR has taken its vision and success outside Hong Kong.

"Episode II: Sea Passenger and Cargo" presented by Fat Kee Stevedores Ltd. (FKS) and Hong Kong Ferry (Holdings) Co. Ltd. (HKF) on 14th July 2018.

FKS founded in 1949, is a long established logistics operator in Hong Kong which provides high quality services in land and sea transportation, distribution center operations, supply chain solutions and waste logistics management. FKS has witnessed the changes of development in Hong Kong and transformed itself from a small set up company which relied substantially on manual labour to a multi-disciplinary organisation today. Mr. David KONG, Managing Director of FKS and the Executive Director, Mr. Terence YAN, shared with the audiences their experience on how FKS morphing itself with Hong Kong and how they position FKS to tackle the challenges and grasp the opportunities ahead.

The Hongkong & Yaumati Ferry Co. Ltd. (HYF), is part of Hong Kong Ferry (Holdings) Co. Ltd. (HKF), has been providing ferry service in Hong Kong for almost a century since 1923. Before cross harbour tunnels and metro were built, ferry was one of the most important modes of transportation in the city and HKF was one of the major ferry service providers to islanders. Ir Willie YEUNG, Deputy General Manager of HYF gave a brief review of the company's history and presented how HKF and HYF adopt and develop themselves to cope with the changes throughout the years.

This seminar series would not be succeeded without the unfailing support of the above participating companies and HKU SPACE Centre for Logistics and Transport in co-organising the July seminar at their Admiralty Learning Centre.

ii) "CILTHK Seminar: To Automate or Not to Automate, that is the question for Hong Kong e-Commerce Logistics" presented by Prof George HUANG, Professor and Head of Department of Industrial & Manufacturing Systems



Engineering of HKU on 25th September 2017

Irrespective of ecommerce has been developed dramatically over the years and becomes a great opportunity for Hong Kong logistics industry, its development shown a bottleneck no matter it is online or offline or O2O. The large quantity and variety require high operational efficiency. That is not easy to achieve with manual handling and automation is considered. In view of the typical warehouse tenancy in Hong Kong is in the range of 2 to 5 years, it is challenging to a logistics operator to invest on automation in such a short period of time. To combat the challenge, Prof George HUANG introduced a game theoretic business model for ecommerce warehouse automation. Also, various approaches and options of smart automation for ecommerce logistics were shared in the seminar.

iii) "Joint Seminar: How the local SME logistics practitioners can capitalise on China's Cross Border E-commerce Opportunities", presented by Mr. Terry CHAN, Chairman of Hong Kong eCommerce Supply Chain Association; Mr. Andy LAM, Honorary President of Hong Kong Cross Border E-commerce Association; Mr. Lawrence LI, Director of Brand Express; Mr. YK IP, Senior Manager of The BUD Fund Secretariat of Hong Kong Productivity Council on 15th December 2016

As the 12 comprehensive pilot zones were approved to be set up in January 2016 by the State Council in Tianjin, Shanghai, Chongqing, Hefei, Zhengzhou, Guangzhou, Chengdu, Dalian, Ningbo, Qingdao, Shenzhen and Suzhou, together with Hangzhou which was approved earlier, the cross-border e-commerce trade has become a new economic growth engine. In the first half year of 2017, these pilot zones had registered the total imports and exports exceeding RMB100 billion, more than a double year-on-year increase.

With the generous support of the 4 industry experts in the area of cross-border e-Commerce trade, the joint seminar was held successfully in collaboration with the SCR of PolyU, HKIE-LTD and IPSHK at PolyU which attracted about 100 participants to attend. The speakers shared and exchanged their unique insights and experiences towards the evolution and innovation of the e-Commerce ecosystem in Hong Kong and mainland China, and the challenges and opportunities for the local SME logistics companies in the megatrends were also discussed.

iv) "CILTHK Seminar: Human Remains Shipment", presented by Mr. Alan LEUNG, FCILT, Founder and Director of A&G Logistics Ltd. on 23rd October 2017

Suffering the loss of a loved one is one of the most sadness and difficult things we may face especially when unfortunate incident happened overseas. Mr. Alan LEUNG, FCILT, has been running special services in human remains delivery by his company, A&G Logistics Ltd. In the last two decades, over 1,500 cases of human remains shipments from Hong Kong to worldwide have been handled. Mr. LEUNG introduced the workflow of handling human remains shipment all the way from airline spacing booking, documentation arrangement, dealing with consulate, shipment arrangement from mortuary to the board of aircrafts. Mr. LEUNG quoted different cases that attracted a great deal of interest from the audiences.



v) "CILTHK Two-day Course 2017 (Part II) – Commercial Arbitration", presented by Mr. Philip YANG, Maritime & Commercial Arbitrator; Prof Albert LEUNG, Director of Operations of Jacobs China Ltd. and Mr. Danny MOK, Maritime and Commercial Arbitrator, on 11th-12th November 2017

This annual flagship event was continued co-organising for members of CILTHK, HKARMS, HKIE-LTD, IMechE(HK) and students. With the continuous support of the Shipping Research Center (SCR) of the Hong Kong Polytechnic University, the course was held successfully at the Jockey Club Innovation Centre, PolyU on 11th-12th November 2017. The theme focused back on "Commercial Arbitration", the 3 keynote speakers elaborated the topics in six informative and valuable lectures with different cases sharing to enable the audiences to understand more easily. The course had attracted over 200 participants to join and led a fruitful discussion.

vi) "How disruptive trend of transports leveraging Google", presented by Mr. Dennis WONG, Director and Co-founder of Master Concept (Hong Kong) Ltd. on 30th November 2017

Digital technology has fundamentally changed the world. This disruptive force is capable in transforming every single industry that change has already with the transport and logistics sectors. Not only the traditional business models have been enhanced and transformed but also new engagement business models were invented, for example, companies like Uber have grown to become multi-billion dollar global enterprises. Mr. Dennis WONG introduced the Google technologies to the participants and shared different cases to showcase how the technologies help the future development of metro, rail, road, air and other automotive industries. Mr. WONG also demonstrated that the Google technologies is not only offering variety of powerful services designed for work and productivity, but also can help individual users and SME to start up their business with very low cost.

vii) "Back to Basics How to handle a Marine Cargo Claim", presented by Ms. Gwenette VETUZ, Consultant and Ms. Helen TANG, Senior Associate of Reynolds Porter Chamberlain on 24th February 2018

Hong Kong serves as a regional hub port to South-East and East Asia, and is considered an economic gateway to mainland China. It is the largest container port serving Southern China and is one of the leading container ports in the world. It is inevitable that cargo claims would arise when such large volume of container trade passes through Hong Kong. Ms. Gwenette VETUZ and Ms. Helen TANG, led the audiences looking into the potential issues which arise in a cargo claim and the best practices in handling them. The seminar covered a wide range of topics in Cargo Claim: life cycle of a Cargo Claim; what to do when a cargo claim arises; what to note as a cargo claimant; what to note when defending a cargo claim; position of a freight forwarder; ship arrest & security; litigation of a cargo claim in the Hong Kong Courts; arbitration & other dispute resolution methods; bill of lading issues, etc.

viii) "The Development & Tactics of Express Giant in Mainland & International Courier Market", presented by Mr. SC YU, CMILT, Associate Director of Economics and Logistics Research Centre of City Think Tank and Member of Logistics Policy Committee of CILTHK; Dr. Simon YUEN, CMILT, Senior



Lecturer & Deputy Scheme Leader of PolyU SPEED and Member of Professional Activities Committee of CILTHK on 6th March 2018

In the wake of a huge demand of China domestic import market and opportunities of exporting China-made products to the global market, several local-based courier firms grasp the opportunity to expand their business since early 90's and now become leading couriers and express giants in mainland China. Mr. SC YU and Dr. Simon YUEN presented an overview of the international, regional and local courier and express market in the seminar. The presentation also included an in-depth review, analysis, tactics and strategy for express service provider to evaluate their competitive advantage and challenges of the business.

ix) "Smart Mobility – Installation of Traffic Detectors on Strategic Routes in Hong Kong", presented by Ir Shirley LEUNG, Senior Engineer/ Survey & Projects of Transport Department, HKSAR Government and Ir Gary LEUNG, Associate Director, Transportation (Traffic & Transport Planning) of AECOM Asia Co. Ltd. on 9th April 2018

Since the completion of the Intelligent Transport Systems Strategy Review Study in 2001, the Transport Department has implemented a wide spectrum of advanced technologies to enhance the efficiency of traffic management and to improve the overall capacity of the road system and safety. Ir Shirley LEUNG and Ir Gary LEUNG were invited to deliver a seminar on how various technologies have been deployed on strategic routes and their application. It was introduced in the seminar that about 400 sets of traffic detectors were planned to be installed along some of the strategic routes to detect vehicles passing by and collect real-time traffic data like traffic volume and speed. By using these advanced traffic detection technology, automatic incident detection and data collection could be achieved continuously 24 hours a day and 7 days a week.

Site/Company Visits

- The following site visits were organised during 2017/2018.
 - i) Hong Kong Shipyard Ltd. on 25th November 2017

CILTHK was pleased to arrange this technical visit for members and industry players in supporting the Hong Kong Maritime Week 2017. Hong Kong Shipyard Ltd. is a wholly-owned subsidiary of The Hong Kong Ferry (Holdings) Co. Ltd. with over 60 years of history in marine engineering. The visit had attracted over 30 people to participate. Participants were enriched with knowledge on the operations and surprised by the comprehensive engineering and maintenance services provided in the shipyard. Ir CHAN Chi Ming, Deputy General Manager also shared the development history of the local ship repair and maintenance by showing numbers of historical visuals and stories which drew an overwhelming responses from the participants.

ii) New CAD Headquarters Building on the Airport Island on 26th January 2018

Apart from the regulatory role, the Hong Kong Civil Aviation Department (CAD)



is the sole air navigation of air traffic control services to all aircraft operating at the Hong Kong International Airport (HKIA) and within Hong Kong Flight Information Region (HKFIR). CAD supports safe, reliable and efficient air traffic services by exploring and implementing the latest aviation technologies and initiatives promoted by the International Civil Aviation Organisation (ICAO). Mr. Raymond LI, Assistant Director-General and Mr. Bill LEUNG, Senior Operations Officer (Technical Administration) introduced the Air Traffic Control Units, Air Traffic Control Sectorisation plan, air route network of HKIR, 3-runway system and the new Air Traffic Management System (ATMS) which has been commissioned in 2016 for the future 3-runway development and the increasing air traffic growth at the visit. The visiting group was also brought to tour around the aviation education path where showing the local aviation development, global cooperation and worldwide network, aircraft model gallery and the aircraft simulator. Participants were attracted and impressed by the rapid development and sophisticated technology that applies in CAD.

iii) Government Flying Service on 6th July 2018

The Government Flying Service (GFS) is one of the disciplined services of the HKSAR Government which operates in accordance with the civil aviation rules and provides the community of Hong Kong with a broad spectrum of flying services, including round-the-clock search and rescue, emergency air ambulances, fire-fighting and support to various law enforcement agencies. To carry out these tasks, the GFS is equipped with a mixed fleet of operational aircrafts comprising two fixed-wing aircrafts, three AS332 L2 Super Puma helicopters and four EC155 B1 helicopters. The visiting group was received by Ir Donny CHAN, Chief Aircraft Engineer of GFS and his team. Ir CHAN gave a brief introduction of GFS which allowed the participants to get a glimpse of the total landscape of GFS and their motto 'Semper Paraus' means 'always ready'. Participants were impressed with the operation statistics and duties of GFS that are not aware by the public in general. The visit was ended with the guided tour to the GFS Air Command and Control Centre as well as Hanger for static display of aircraft. Participants found the visit very interesting and informative.





Policy recommendations / Submissions

3. **Submission on Public Transport Strategy Study**, 16th January 2016 The Government released the Public Transport Strategy Study (PTSS) in June 2017.



It reviewed the overall strategic arrangement of transport services other than heavy rail. The Institute opined that the report was a good reflection of the existing practices of the public transport system in Hong Kong. However, as a strategy report, there were much to be desired. A submission was sent to the attention of the Secretary of Transport and Housing for the Government's consideration.

Mr KY LEUNG represented the Institute in attending the LegCo's Panel on Transport Meeting and presenting the Institute's viewpoint on 22nd January 2018

4. Submission on PTSS (Follow-up on THB's reply of 15th February 2018), 11th June 2018

A reply was received from the Transport and Housing Bureau on our former submission on PTSS. Since the last Comprehensive Transport Study was completed in 1999 and there had been major changes at various fronts in past decades. The Institute was disappointed with the Government's reply that there was lacking a comprehensive assessment of the future transport needs and measures that need to be taken to meet the future challenges. The Institute therefore sent a further submission in this regard.

All copies of above letters/submissions and corresponding replies on items 3 & 4 have been posted at the NEWS/POSITION PAPERS page on the Institute website.

During the past year, the following presentations and sharing sessions have been arranged in Transport Policy Committee meetings for discussion:

- 5. Dr. HUNG Wing-tat, Chairman of the Hong Kong Taxi Council, gave a presentation on their Proposed Taxi Reform on 19th December 2017.
- 6. Mr. Joe MA, Deputy General Manager of Shenzhen Bus Group Co., Ltd., was invited to share the electric bus service and development in Shenzhen with members on 6th February 2018. Following the sharing session, a visit to the Shenzhen Bus was arranged for TPC members on 24th March 2018. The highlight of the day was to see the trial on driverless bus, as well as the operation of electric buses. It was a fruitful visit to help members learn more about Shenzhen's experience.
- 7. The Transport Department (TD) conducted a "Consultancy Study on Enhancing Walkability in Hong Kong Feasibility Study" in May 2018. Staff of TD and Mott MacDonald (the consultancy firm) were invited to give a presentation on the study and exchanged views and experience on walkability and application in Hong Kong with members on 19th June 2018.
- 8. Mr. Alok JAIN, CMILT, TPC member gave a presentation on "Artificial Intelligence in Public Transport" on 21st August 2018.



WiLAT Survey 2018

3. In a highly competitive operating environment, retention of talent is a key factor for success in the business community. The same speaks for the supply chain, logistics and transport industry. To encourage diversity and to develop the potential of our young talent and in particular female employees, Women in Logistics and Transport, Hong Kong conducted a comprehensive online survey among members of the Institute and supporting organisations on how to attract and retain female talent in the industry. The survey was professionally supported by HKU SPACE Survey team.

The survey has learnt about the key factors affecting female decisions in joining the supply chain, logistics and transport sector, the hindrances they face in their mid-careers and what measures could help them to retain them in the industry. More than 14% of CILT HK members responds were collected. In addition, a good number of non CILT members and organisations have also participated the survey with good input. Infographics from the survey result was shared with Global WiLAT at ICM Poland; and the full report have been distributed to key government departments in Hong Kong as well as other women organisations and key industry players. The survey was conducted between 12th March and 9th April 2018 and the key findings are summarised below:

4. CALF 2017 Graduation Ceremony on 27th August 2018

Career and Life Formula (CALF) Professional Advancement Programme for Young Managers of the Logistics & Transport Industry was jointly organised by Women in Logistics and Transport, Young Members Committee, Education and Training Committee and Logistics Policy Committee of CILTHK. 16. **3rd World Transport Convention in Beijing** on 19th-20th June 2018

The Convention was co-organised by the Chinese Engineering Academy with Tsinghua University as a supporting organisation. CK LOH spoke on Singapore experience in building a liveable and congestion free city; and Dorothy CHAN introduced Hong Kong's Railway Led Development Strategy which allows the development of properties above railway stations. There were speakers from Japan and Korea and it was apparent that the Asia cities have a common strategy to develop mass transit as a means to main mobility. Other speakers were from Germany, Japan and Korea.

17. **CILT ICM at Poland** on 3rd-6th June 2018

Next ICM will be held in Manchester, UK from 16th-18th June 2019. 2019 is the Centennial celebration of CILT.

She also pledged to use her best endeavour to promote diversity and equal opportunity and while she was receiving her award, she was thinking of the bigger WiLAT family.
