The Chartered Institute of Logistics and Transport Suggestions on Logistics and Transport for the Policy Address 2020

After due consultation from more than thirty (30) leading and sizeable companies in logistics and transport in Hong Kong and also other professional members in the Industry, the Institute as a learned and leading professional Institution furnished our suggestions on the 2020 Policy Address in relation to logistics and transport for the consideration of the Chief Executive.

Our suggestions for 2020 Policy Address on transport cover four main areas, they are:-

- 1. Comprehensive Transport Study;
- 2. Encouragement on the use of public transport;
- 3. Environmental sustainability and road safety;
- 4. Immediate measures for tackling traffic congestion.

While our suggestions for 2020 Policy Address on logistics cover another four main areas, they are:-

- 1. Greater Bay Area;
- 2. Leading initiatives for development of logistics;
- 3. Talent management;
- 4. Relief measures against impacts from Covid-19.

Press Conference on Appealing with the Government for Relief Measures under Anti-Epidemic Fund 3.0

Since the outbreak of the COVID-19 in January, the epidemic has spread globally, causing economic activities into a halt and global supply chains being affected. Hong Kong as an important transit port in the region, stakeholders in the logistics industry: supply chain, transportation including land, sea & air, freight forwarding and warehousing, have all been severely impacted.

Although relief measures have been introduced by the HKSAR Government in past months and some do help reduce the financial burden of logistics operators, more relief measurers are needed under the current difficult times. Hence, 12 local professional bodies in freight forwarding, transport and logistics joined the Press Conference called by Honourable Frankie Yick, Legislative Councillor for the Transport Functional Constituency, on 13 August 2020 in appealing for further government relief measures under the Anti-Epidemic Fund 3.0.

- 1. Provide 2-month rental and management fee allowance;
- 2. Extension of the existing waiver/reduction on government fees/charges for 6 months;
- Extension of the arrangement for interest repayment and non-repayment of principal for 6 months;
- Extension of the six-month Employment Support Scheme, and the inclusion of employees over 65 years of age who do not have an MPF account;
- Release of the Anti-Epidemic Fund 3.0 as soon as possible, and the former financial subsidies will be continued and to ensure subsidisation to industry sectors which have been missed in the previous two rounds of epidemic fund can be dealt with first.

CORONAVIRUS (COVID-19) OFFICIAL UPDATES



STRONGER TOGETHER

CILT Hong Kong responded to the call from Dato' Ts Abd Radzak Abd Malek, our International President, to carry out local research and build up a local response to a series of questions relating to the COVID-19 crisis. The below two papers have been published.

The disruption of supply chains and the reduced cargo demands exacerbated by national lockdowns on the one hand, and the persistent increase in logistics costs due to fluctuating air and sea carriage capacities on the other have badly hurt the bottom line of all enterprises, and precipitated liquidity problems to many. Only a few industry sectors have been weathering the storm better than others.

Many logistics practitioners in Hong Kong will re-position themselves to exploit the opportunities emanated from the anticipated changes in supply chains in the post-COVID-19 world. On the demand side, there will be new logistics opportunities for the S.E. Asia and S. Asia markets where partnership with the local people can provide cost-effective end-to-end service deliverables. On the supply side, synergetic co-operation with industries in the Guangdong-Hong Kong-Macau Greater Bay Area, supported by technologies like Block Chain and robotics, will help improve process efficiency, save cost and ultimately enhance customer experience and business sustainability.

This report briefly mentions the traffic and transport situation and the responses of our industry in meeting the COVID-19 challen ge in the first half of the year. Both traffic flow at checkpoints and patronage dropped severely. The local and cross harbour traffic at checkpoints showed in the critical months of February to April reduced by about 14-22%, while that for the Lantau Link and the cross boundary points were reduced by 36-62%. On the public transport side, the average daily public transport passengers in the first five months of 2019 was 13 million. However, for the corresponding period in 2020, the figure was only 8.6 million, representing a drop of about 34%.

Measures taken by the transport operators to counter against the adverse impact brought by the COVID-19 include:

- Adjustments to service operations
- Cost saving measures
- Stringent hygiene and sanitisation measures
- Measures taken to regain passenger confidence
- Participation in research study, e.g. "Future of Mobility post-COVID", "Low-Carbon Transport, Individual Wellbeing & Planetary Health in the Era of Smart Cities & New Mobilities"

In the concluding paragraphs of the paper, areas which the transport market need to be given more thoughts were listed.

behaviour, expectations from consumers towards retailers for faster delivery times changed the playing field completely. Direct sourcing of Retailer plus Cross-Border Direct-to-Consumer Parcel Solution is the latest step in retail and logistics evolution. Webinar Series: COVID-19: Impact on Logistics and Practical Responses

The COVID-19 outbreak is a global public health crisis which has been threatening the global economy. A team of legal experts from international law firm Holman Fenwick Willan (HFW) conducted a webinar series to discuss with participants the liability issues that arise when doing business in the maritime transport and aviation sectors, as well as sale contracts. The following four sessions were held from June to September.

Session I: Issues arising in Maritime Transport, 8 June 2020

Speaker: Ms Joanne Waters, Senior Associate, HFW

It looked at examples of the disruption which COVID-19 has caused in the maritime industry, affecting supply, demand, people and processes. Ms Joanne Waters led the participants looking at issues arising from delay and means of mitigating delay in future shipments

- 2. Liability for delay in maritime transport
- 3. Check your contracts!
- 4. Regulatory and compliance issues
- 5. Looking ahead
- 6. Conclusions
- 7. Questions

Session II: Issues arising in Aviation,

22 June 2020

Speaker: Mr James Jordon, Senior Associate, HFW

It discussed the challenges that had been created for the air freight industry as a result of COVID-19. From reduced capacity to significant demand increase for particular types of cargo on certain routes, this session assessed the changing risk and regulatory framework and considered what steps entities needed to take in their commercial contracts to protect themselves in a post-COVID-19 world.



Session III: Issues arising in Sale Contracts, 20 July 2020

Speaker: Ms Suzanne Meiklejohn Senior Associate, HFW

It focused on the most common issues arising out of COVID-19 within the context of commodity sales contracts, particularly force majeure. Ms Suzanne Meiklejohn shared some real life cases to elaborate how they have been helping their clients and in which cases taking account of some of the knock-on effects of the COVID-19, such as counterparty defaults, and offer practical tips for navigating these ongoing issues.



Session IV: HWF's Impact Model for Logistics, 21 September 2020

Speakers: Mr Craig Neame, Head of Logistics Department, HFW; and Ms Joanne Waters, Senior Associate, HFW

HFW's market-leading logistics team, led by Craig Neame, has developed a "Coronavirus Impact Model" which aims to map out the potential impact of the virus on businesses in the shipping and logistics industries. The Impact Model is the result of a series of internal HFW workshops and extensive discussions with senior key stakeholders across these sectors. It aims to highlight some of the potential risk and impacts that might arise in the four dimensions of a company's business and acts as a tool to help businesses develop risk management strategies

and solutions. In the last session, Craig and Joanne presented the model and demonstrated how it could be used to assist businesses to identify risk and build resilience for the new normal.

Session I: How do we make Hong Kong a Smart Cities? 8 September 2020

The first Session was delivered online by Dr C.H. Cheng on 8 September. Six pillar approach including smart mobility, smart living, smart environment, smart people, smart government, and smart economy has been adopted in building a smarter city in Hong Kong.. Despite of diverse settings and applications, technologies are the indispensable foundation for developing and implementing a smarter city. Dr Cheng discussed some selected technologies for smart city developed by Logistics and Supply Chain MultiTech R&D Centre. The illustrated example technologies spanned from sensing devices from video cams and from AI to systems. Realistic cases were also outlined to demonstrate the applicability of these technologies.




Member's Log-in

For the first time log-in, please click "Forgot Password" to receive the email for setting up your new password (in future, you may follow the same procedure to reset your password).


