There being a quorum, the meeting proceeded to business. Dr. Venus Yuen-ha LUN, FCILT, President, took the chair.

#### 1 Welcome address by the Chairperson

1.1 The Chairperson welcomed members, Mr. Ronald LEE representing Ronald H.T. Lee & Co, Honorary Auditor; Mr. Alex NGAI, representing Mr. David BEAVES, Honorary Legal Advisor, and guests to the Annual General Meeting 2019.

### 2 Notice of Meeting

2.1 The Chairperson noted that the Notice convening the Meeting had been served to members for the prescribed period. The Notice was taken as read.

# 3 Receipt of Proxy Forms

3.1 The Chairperson reported that NO (0) Proxy Form had been received from Institute Member.

The following resolutions were passed:

# 4 To receive and adopt the minutes of the AGM 2018 held on 20<sup>th</sup> September 2018

4.1 There being no other amendments, the minutes were confirmed. The motion was proposed by Mr. Sunny Lap-kee HO, FCILT, and seconded by Ir Dr. Vincent Ping FONG, FCILT. The meeting adopted the minutes of AGM 2018 as a true and correct record.

### 5 To receive and adopt 2018/2019 Annual Report of the Council

- 5.1 The meeting received and noted the Annual Report for the year 2018/2019.
- 5.2 There were no questions or enquiries raised by members in relation to the committee reports. The meeting confirmed the adoption of the Annual Report 2018/2019. The motion was proposed by Mr. William Chak-man CHUNG, FCILT, and seconded by Mr. Sunny Lap-kee HO, FCILT.

- To receive and adopt the Institute's Financial Report for the year ending 31<sup>st</sup> December 2018
- 6.1 The Chairperson reported the Institute's financial performance at the year end in 2018 that an operational deficit of HK\$15,817 was recorded whereas the cash balance was HK\$4.75 million. Though a small deficit was recorded, the Institute continued in maintaining a healthy financial position.

There were no questions or enquiries raised by members in relation to the financial report. Ir Dr. Vincent Ping FONG, FCILT, proposed that the Financial Report for the year ending 31<sup>st</sup> December 2018 be accepted. The motion was seconded by Mr. Eric Man-sum WONG, FCILT, and endorsed by members.

- 7 To re-appoint Ronald H.T. Lee & Co. as the Honorary Auditor to audit the account for the financial year ending 31<sup>st</sup> December 2019
- 7.1 Prof. Becky Pui-ying LOO, FCILT, proposed, seconded by Mr. TSANG Wing-hang, FCILT, and the meeting endorsed the re-appointment of Ronald H.T. Lee & Co. as the Honorary Auditor for the financial year ended 31<sup>st</sup> December 2019.
- To consider and pass Special Resolution on the adjustment of the Annual Subscriptions and Election Fees for Membership effect from 1<sup>st</sup> October 2019 (Appendix II)
- 8.1 The Chairperson reported that Annual Subscription was the main source of income of the Institute. To maintain the financial sustainability of the Institute, the Council had discussed and approved a policy that the Annual Subscriptions and Elections Fees would be reviewed in every 2 years.
- 8.2 In view of the accumulated inflation since the last review of Annual Subscriptions and Election Fees in 2016, the Council proposed adjustments as per Table 1 in Appendix II for members' adoption.
- 8.3 There were no enquiries or questions raised by members. It was supported by all 26 Institute Members attending the meeting, i.e. 100% voted for the motion. The motion to adopt the adjustment of the Annual Subscriptions and Election Fees for Membership effect from 1<sup>st</sup> October 2019 was approved and adopted.

# PRESIDENT'S REPORT

# By Dr. Venus Yuen-ha LUN, FCILT President

It was indeed a privilege to be a President of the Chartered Institute of Logistics and Transport in Hong Kong whereas the Centenary Celebration of CILT fell within my 2-year presidency term. The Institute has a long and proud history of service to members and the community. One hundred years dedicated to improving standards, providing education, and supporting professionals across the world

In the beginning of the year 2020, again, we have been facing an unordinary year with challenges arising from the COVID-19 pandemic. The pandemic has accelerated changes that may have been under consideration for some time but are now a reality. With the support of fellow Council Members, different tasks were completed irrespective of the difficult situation. I am pleased to present to our members herewith the 2019/2020 Council Report.

Soon after the severe outbreak of COVID-19, some of the Institute's planned activities have to be cancelled or rescheduled but the Institute business has been kept on without much disruption and activities have been resumed normal from April onwards. Please find the below summaries (a list of major events and achievements are given in this Council Report):

- 4 submissions to the Government were tendered for improving the development in transport and logistics, and life in Hong Kong;
- 2 research papers on the impacts of COVID-19 to transport and logistics respectively
- Joined hands with other local professional bodies in appealing for Government's relief measures for transport and logistics industry
- 12 webinars have been organised

The membership now stands at 1,866, with a total of 373 successful new/upgrade membership applications awarded last year. Irrespective of a drop in total number of members against last year, it was encouraging to see more than 100 new/upgrade membership applications had been received than in the former year.

#### **HIGHLIGHTS OF THE YEAR**

#### Membership

There were a total of 373 successful new membership applications (265 in 2018/2019); the total membership was 1866 (1889 in 2018/2019; a drop of 1.2%). It was noted number of resignation from members on reason of retirement was increasing, and higher number of drop-outs from graduates who would not able to enjoy the free membership as they were students.

The Institute will closely work with programme leaders/directors of accredited programmes in attracting students to become Student Members. A first promotional video has been produced so programme leaders/directors are enable to promote our profession at academic institutions. Other membership drive works targeted Organisation Membership and individuals in Greater Bay Area in Mainland China will be continued.

Mr. Sunny Lap-kee HO, FCILT, has been conferred with the CILTHK President 2020. Mr. Ho served the CILTHK Council and various committees since 2002, former President in 2014-2016 and has been CILT International Vice President since 2016. Given his extensive knowledge and experience, contribution to the industry, the Institute and the community, Mr. Ho is deserving for the honour.

#### **Finance**

An operation surplus of Hk\$17,551 was recorded in the year 2019 (there was a deficit of HK\$15,817 in year 2018).

As at 31<sup>st</sup> December 2019, the Institute recorded net assets of \$6,590,551 (Year 2018: \$6,605,000); the cash balance of \$4.93M (Year 2018: \$4.75M). I am pleased to report the Institute still maintains a healthy financial position.

# Celebration of the 100<sup>th</sup> Anniversary of the Chartered Institute of Logistics and Transport (CILT) in 2019

As reported in last year, CILT launched a global centenary campaign to celebrate the 100<sup>th</sup> Anniversary in 2019. The highlight was a gathering on 3<sup>rd</sup> November 2019 at Savoy Hotel in London where was the place the Institute inaugurated in 1919. A small scale of CILT Centenary Dinner was also hosted in Hong Kong on 3<sup>rd</sup> November 2019 when was joined by over 100 guests. The Institute was honoured to have the presence of Mr. Chan Fan, Frank, JP, Secretary for Transport and Housing as our Guest of Honour; and Ms. Mable Chan, Commissioner for Transport as one of our VIP Guests.

The CILT global centenary campaign was to focus on members and the benefits of belonging to the international family. It was beyond a celebration of 100 years of existence but on why CILT is relevant to our members, and how we may continue to be so for the next 100 years.

#### **Relationship with CILT International**

CILTHK continues to support the international affairs of CILT in International Management Committee, Women in Logistics and Transport, Next Generation (former name was Young Professionals) and act as an International Secretariat on membership administration (Institute Branches). Institute representatives were supported to attend international and regional convention/conferences (please refer to details in the SC Report on pp26-27 and WiLAT HK Report on pp55-57).

### **Professional Development for members**

Among our important tasks, the Institute is obliged to help human capital development in the

transport and logistics field. It was unfortunately due to the outbreak of COVID-19, professional activities had to be cancelled in the first quarter of the year. Gradually, professional development activities have been resumed and conducted online and we are pleased the new mode has been well received by members. As webinars were streamed live so members from different parts of the world can fully participate.

In the year 2019/2020, the following CPD activities were organised by the Professional and Marketing Activities Committee (PMAC):

Other professional activities especially for female group and young members were also organised by Women in Logistics and Transport, Hong Kong (WiLAT) and Young Professionals Committee (YPC) (please refer to details in the WiLAT HK Report on pp55-57 and YPC Report on pp58-59).

### **Enhancing the brand**

The CILT Award 2020 - "Service Excellence" was successfully held and the awardees are:

- Enterprise Award: Kerry Logistics (HK) Ltd
- SME Award: Janco Global Logistics Ltd.

Winning stories of the awardees will be published in CILTHK's eNewsletter and on Ming Pao. The award was held in every 2 years. Companies/organisations in the transport and/or logistics sectors are encouraged to share their best practice through participating this unique industry award.

eNewsletters (Issues 78 & 79) were published since the last AGM in 2019 which were shared with members in Hong Kong, students undertaking accredited programmes and worldwide CILT members through electronic means. A combo print comprised of Issues 76-78 was posted to every member, government departments, academic institutes, professional bodies, etc

On 31<sup>st</sup> August 2020, the brand new CILTHK website (<a href="https://www.cilt.org.hk">https://www.cilt.org.hk</a>) was launched. Other than a fresh look, readers will be easy to access information from the new website and the Institute wish to establish this website as a source of information for all readers.

### **Submissions and Public Service**

One of the objectives of the Institute is to serve for the betterment of the community. Among other contributions, the Institute has been offering timely professional views and advices to the Government on different transport and logistics matters in Hong Kong.

Four submissions were made by the Institute during the year:

- 2025 Air Quality Objectives Review, 11<sup>th</sup> October 2019
- Submission for the 2020-2021 Budget, 17<sup>th</sup> December 2019
- Addressing the Pain Points of Hong Kong's Logistics Service Providers in 2020, 20<sup>th</sup> March 2020
- Submission for the Address Policy 2020, 15<sup>th</sup> September 2020

In responding to the call from the International President on conducting researches and sharing of best practices – Marketing responses to COVID-19, two papers were shared with

global CILT families through the CILT International Bulletin 07 and 08.

- Impact of COVID-19 on Hong Kong's Logistics Industry
- Impact of COVID-19 on Hong Kong's Transport

There were two occasions, on which I was able to convey the Institute's views and industry's expectations to the government. I was invited to attend the "Consultation Session on Budget 2020-2021" hosted by the Financial Services and the Treasury Bureau on 26<sup>th</sup> November 2019. The second was the "Consultation Session on Policy Address 2020" hosted by the Chief Executive on 24<sup>th</sup> August 2020.

In addition, Institute representatives have been appointed in various government advisory boards and academic advisory boards of local university and college (please refer to p29 for details of CILTHK representatives).

## **Uphold of Professionalism**

New applications for programme accreditation and extension of the current exemption to new streams have been received.

Four new applications for programme accreditation were received during the year:

- Advanced Diploma in Transport Operations and Management, MTR Academy
- BBA (Hons) in Global Marketing and Supply Chain Management, The Open University of Hong Kong
- BSc (Hons) Aviation Operations and Systems, The Hong Kong Polytechnic University
- New stream under BBA in Supply Chain Management (Hons), The Hang Seng University of Hong Kong

The election criteria for both Chartered Fellowship (FCILT) and Membership (MILT) have been reviewed (please refer to p39 of the Membership Committee Report for details).

### **Nurturing the Young Generation**

Due to the COVID-19, classes in both secondary and tertiary levels have been suspended. In this connection, the below academic events were called off this year:

- The CILTHK Student Day 2020 and the 18<sup>th</sup> CILTHK Student Essay Competition (for secondary school students)
- The CILTHK Logistics & Transport Student Final Year Project Award 2020
- The CILTHK Scholarships 2020

Though physical meetings/activities were infeasible during this pandemic condition, new mode of conduction of events through online platform open new alternative and has been well received by members. The online HR Sharing Session organised by our YPC in June was able to provide timely support and information to young members especially those graduates.

#### **ACKNOWLEDGEMENT**

I close with a note of sincere appreciation to my fellow Council Members, members of Council Committees who are unfailingly committed to serving the Institute. Again, I have to express the heartfelt gratitude for the continuous support from our Organisation Members in Institute affairs and your sponsorships for our events. #### 1. GENERAL

This paper provides an overview on the financial status of the Institute for the year ended 31<sup>st</sup> December 2019.

#### 2. FINANCIAL STATUS REVIEW

The Audited Accounts for the year ended 31<sup>st</sup> December 2019 have been examined with the following highlights.

### 2.1 **2019 Results**

The Institute recorded an operating surplus of \$17,551 in 2019 (Year 2018: a deficit of \$15,817).

### 2.2 Balance Sheet

As at 31<sup>st</sup> December 2019, the Institute recorded net assets of \$6,590,551 (Year 2018: \$6,605,000). Cash and the cash equivalents as at the balance sheet date recorded at \$4.93M (Year 2018: \$4.75M) including funds held on behalf of WiLAT.

### 3. REVIEW OF THE YEAR

Notwithstanding the above, we are pleased that the Institute, as a non-profit organisation, continued to maintain a fair and healthy financial position.

### 4. LOOKING AHEAD

The Finance Committee will closely monitor the Institute's financial situation and work with respective committee chairs on maintaining costs within the budget.

# HONORARY AUDITOR'S REPORT For the Year ended 31<sup>st</sup> December 2019

Independent Auditor's Report to the Members of The Chartered Institute of Logistics and Transport in Hong Kong (Incorporated in Hong Kong and limited by guarantee)

### **Opinion**

We have audited the financial statements of The Chartered Institute of Logistics and Transport in Hong Kong (the "Institute") set out on pages 15 to 24, which comprise the statement of financial position as at 31 December 2019, and the income statement and statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the financial statements of the Institute are prepared, in all material respects, in accordance with the Hong Kong Small and Medium-sized Entity Financial Reporting Standard ("SME-FRS") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and have been properly prepared in compliance with the Hong Kong Companies Ordinance.

### **Basis for Opinion**

We conducted our audit in accordance with Hong Kong Standards on Auditing ("HKSAs") and with reference to Practice Note 900 (Revised), Audit of Financial Statements Prepared in Accordance with the Small and Medium-sized Entity Financial Reporting Standard issued by the HKICPA. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Institute in accordance with the HKICPA's Code of Ethics for Professional Accountants ("the Code"), and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

#### Other Information

The Council Members are responsible for the other information. The other information comprises the information included in the President's Report and Honorary Treasurer's Report, but does not include the financial statements and our auditor's report thereon.

Our opinion on the financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

# **Reporting Entity**

The Chartered Institute of Logistics and Transport in Hong Kong (the "Institute") is a body corporate incorporated in Hong Kong as an institute limited by guarantee. The Institute's registered office is located at 7/F., Yue Hing Building, 103 Hennessy Road, Wanchai, Hong Kong. The principal activities of the Institute include, inter alia, to promote, encourage and co-ordinate the study of the science and art of transport; to initiate, foster and maintain investigation and research into the best means and methods of any appliances for transport, transit and locomotion and the problems that are involved and their most satisfactory solution; to extend, increase and disseminate knowledge and exchange information and ideas in regard to all questions connected therewith; and to assist and further in all practicable ways the development and improvement of transport, transit and locomotion in the best interest of the community. The liability of the members is limited to contributing to the assets of the Institute to the extent of HK\$10 each in the event that the Institute is wound up.

### 1. Basis of Preparation and Accounting Policies

The Institute qualifies for the reporting exemption as a small guarantee company under Section 359(1)(a) of the Hong Kong Companies Ordinance (Cap. 622) and is therefore entitled to prepare and present its financial statements in accordance with the Small and Medium-sized Entity Financial Reporting Standard (SME-FRS) issued by the Hong Kong Institute of Certified Public Accountants.

These financial statements comply with the SME-FRS and have been prepared under the accrual basis of accounting and on the basis that the Institute is a going concern.

The measurement base adopted is the historical cost convention.

The following are the specific accounting policies that are necessary for a proper understanding of the financial statements:

### a) Revenue Recognition

Revenue is recognized when it is probable that the economic benefits will flow to the Institute and when the revenue can be measured reliably, on the following bases:

- (i) Members' subscription fees are recognized on a time proportion basis.
- (ii) Accreditation income, advertising income, administrative income and income from examinations are recognized at a point in time on completion of services.
- (iii) Interest income is recognized on a time proportion basis taking into account the principal outstanding and at the interest applicable.
- (iv) Members' entrance fees are recognized at a point in time on completion of assessment services by granting the qualification and status to the applicants.
- (v) Revenue from activities is recognized upon completion of the relevant events.

# 1. Basis of Preparation and Accounting Policies (Cont'd)

### b) Foreign Exchange

The reporting currency of the Institute is Hong Kong Dollars, which is the currency of the primary economic environment in which the Institute operates.

Foreign currency transactions are converted at the exchange rates applicable at the transaction dates. Foreign currency monetary items are translated into Hong Kong Dollars using exchange rates applicable at the end of the reporting period. Gains and losses on foreign exchange are recognized in the income statement.

# c) Property, Plant and Equipment

Property, plant and equipment are stated at cost less accumulated depreciation and impairment losses, if any.

The depreciable amount of an item of property, plant and equipment is allocated on a systematic basis over its estimated useful life using the straight-line method. The principal annual rates used for depreciation are as follows:

Leasehold land Over the remaining lease term

Buildings 2.5% Leasehold improvements 20% Furniture and equipment 20%

# d) Impairment of Assets

An assessment is made at the end of each reporting period to determine whether there is any indication of impairment or reversal of previous impairment, including items of property, plant and equipment. In the event that an asset's carrying amount exceeds its recoverable amount, the carrying amount is reduced to recoverable amount and an impairment loss is recognized in the income statement. A previously recognized impairment loss is reversed only if there has been a change in estimates used to determine the recoverable amount, however not to an amount higher than the carrying amount that would have been determined (net of depreciation), had no impairment losses been recognized for the asset in prior years.

## e) Accounts and Other Receivables

Accounts and other receivables are stated at estimated realizable value after each debt has been considered individually. Where the payment of a debt becomes doubtful a provision is made and charged to the income statement.

## f) Retirement Benefit Costs

The Institute participates in a Mandatory Provident Fund Scheme (the MPF scheme) under the Hong Kong Mandatory Provident Fund Schemes Ordinance for employees employed under the jurisdiction of the Hong Kong Employment Ordinance and not previously covered by the defined benefit retirement plan. The MPF scheme is a defined contribution retirement plan administered by independent trustees. Under the MPF scheme, the employer and its employees are each required to make contributions to the plan at 5% of the employees' relevant income, subject to a cap of monthly relevant income of HK\$30,000. Contributions to the plan vest immediately.

### g) Leases

Leases that transfer substantially all the rewards and risks of ownership of assets to the Institute are accounted for as finance leases. At the inception of a finance lease, the cost of the leased asset is capitalized at the fair value of the leased asset or, if lower, at the present value of the minimum lease payments. Lease payments are apportioned between the finance charges and reduction of the lease liability so as to achieve a constant rate of interest on the remaining balance of the liability. Finance charges are charged to the income statement.

Capitalized leased assets are depreciated over the shorter of the estimated useful life of the asset or the lease term.

Leases where substantially all the risks and rewards of ownership of assets are not transferred to the lessee are accounted for as operating leases. Annual rents applicable to such operating leases are charged to the income statement on a straight-line basis over the lease term.

### h) Cash and Cash Equivalents

Cash and cash equivalents comprise cash at bank and on hand and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value. Bank overdrafts that are repayable on demand and form an integral part of the Institute's cash management are also included as a component of cash and cash equivalents for the purpose of the cash flow statement.

### 2. Revenue

Revenue represents members' subscription fees.

    - In Hong Kong, a CILT Centenary Dinner 2019 was hosted at the Chinese General Chamber of Commerce when Mr. Chan Fan, Frank, JP, Secretary for Transport and Housing, was invited as our Guest of Honour.

- Both Dr. Dorothy Chan, FCILT; and Mr. Keno Cheung, CMILT, contributed their 'I AM CILT' videos for the centennial campaign - 100 CILT individual membership stories.

### Appealing for Government's Relief Measures against COVID-19

- 5. The Hong Kong economy has been hard hit by the pandemic. The Institute joined other local professional bodies in urging for Government's relief measures for the logistics industry.
  - The first joint appeal by 7 professional bodies to the Chief Executive was submitted on 19<sup>th</sup> February 2020
  - A follow-up appeal by 9 professional bodies for Speedy Implementation of Government Relief Measures was issued on 31<sup>st</sup> March 2020
  - A first meeting with Mr. Frank Chan, JP, Secretary for Transport and Housing, on health declaration/certificates required by cross-border drivers on 2<sup>nd</sup> April 2020
  - A follow-up meeting with Mr. Frank Chan, JP, Secretary for Transport and Housing; and Dr. Raymond So, Under Secretary for Transport and Housing, on rent and wage subsidies for logistics industry on 6<sup>th</sup> April 2020
  - A Press Conference in appealing landlords on rent reduction for offices/ warehouses on 14<sup>th</sup> April 2020
  - Responded to the initiative of Hon Frankie Yick, Legislative Councillor, a Press Conference joined by 12 professional bodies was held on 13<sup>th</sup> August 2020 in urging the Government for further relief measures for logistics industry under Anti-epidemic Fund 3.0
- 6. CILTHK is appointed by the Government in managing the 'Job Creation Scheme for the Logistics Industry: University Graduates Subsidy Programme'. The Scheme will soon be launched and open for application.
  - The Scheme will provide time-limited financial support to qualified employer with a view to sustaining the provision of job opportunities for 2018, 2019 or 2020 graduates to work in logistics-related areas and to relieve the employment difficulties under the impact of the COVID-19 epidemic.

#### **CILTHK President Award 2020**

7. The Award is to honour the outstanding contribution of individual members to the Institute and transport/logistics sector. Mr. Sunny Lap-kee HO, FCILT, is conferred for this prestigious award. Mr Ho served the CILTHK Council and various committees since 2002, former President in 2014-2016 and has been CILT International Vice President since 2016. Given his extensive knowledge and experience, contribution to the industry, the Institute and the community, Mr Ho is deserving for the honour.

# **International Symposium on Road Congestion Charging 2019**

8. As reported in last year, the Symposium was jointly organised with The Hong Kong Institution of Engineers – Logistics and Transportation Division (leading organisation), Intelligent Transportation Systems Hong Kong, and The Chartered Institution of Highways and Transport (Hong Kong Branch).

### **Membership Retention and Membership Drive**

9. A task force has been set up to better serve our Organisation Members. It is proposed to meet Organisation Members regularly so to be able to better understand their latest concerns in the industry and their expectations from CILTHK. However, due to the pandemic, the gathering with Organisation Members will have to be put on hold.

In preparing the Institute's submission on Policy Address 2020 to the Government, a consultation through emails have been distributed to all our Organisation Members in collecting their views and suggestions.

- 10. It was discussed with CILT China in expanding the Hong Kong membership to prospective members in Greater Bay Area. The Hong Kong initiative was fully supported by CILT International. It is firstly to target senior executives in private enterprises in GBA. The first recruited FCILT is Mr. Lai Xueqiang, Ryan, Founder of Shenzhen Chefuwang Logistics Ltd. More works will be planned after the pandemic.
- 11. Inclusion of CILTHK members as Individual Electors in Transport Functional Constituency
  - It was reported by Mr. TSANG Wing-hang in his President Report in 2017 that we wrote to the Constitutional and Mainland Affairs Bureau on the subject matter. A reply was received from the Government on 2<sup>nd</sup> December 2019 (<a href="https://www.cilt.org.hk/en-us/publication/file.aspx?id=137">https://www.cilt.org.hk/en-us/publication/file.aspx?id=137</a>) that our proposal would not be considered at this stage. The Institute will continue follow up the discussion with Government at suitable time in future.

- 14. The Institute has been contacted by the Commerce and Economic Development Bureau in assisting to kick off a discussion on the deployment of 5G technology in the logistics and transport industry.

Since the national strategy of China 'One Belt One Road' launched in late 2013, Sino-Europe Freight Trains cross over mainland China and continental Europe has become an important platform. Mr. Y.K. Chan shared how Sino-Europe Freight Trains works; its pros and cons and the opportunity for Hong Kong in the seminar. As one of the few surviving professionals in the world that operated container freight service via The TranSiberian Railway in the 1980s, Mr Chan also shared different interesting stories of the Russian railway with the participants.

ii) CILTHK Workshop "Liability in Logistics" by Ms. Joanne Waters, Senior Registered Foreign Lawyer (English & Wales), Hong Kong and Ms, Nicola Tune, Registered Foreign Lawyer (England & Wales), Hong Kong of INCE & Co on 20 July 2019

Liability in logistics can be complicated; the multiple intermediaries, duplicated documentation and multi-jurisdictional nature of international trade often means that establishing who is responsible for claims is not straightforward. Ms. Joanne Waters and Ms. Nicola Tune addressed some of the most common scenarios in logistics which give rise to issues of liability and consider the types of questions that need to be answered in order to establish where liability lies. Joanne and Nicola conducted this workshop by working through 3 case studies drawn from their experience on real-life cases; the topics included dangerous goods, cold chain logistics and cargo damage and delay.

"Minimising Lost from Car Accident by Applying Big Data Analytics to Your Vehicle Network" by Mr. Antonio Wong, CEO & Co-founder of Greensafety Technology Ltd. on 10 September 2019

In 2018, car collisions costed around \$518 billion globally, roughly translating into 1-2% of each country's GDP according to the World Health Organisation (WHO). Minimising the lost from car accidents becomes a valuable topic among the world. Mr. Antonio Wong is a Hong Kong pioneer to promote the service of Driving Safety Solutions to different big corporations since 2015. Antonio explained how could the solutions help the management easily identify the dangerous driving from the drivers and take necessary precautions and also elaborated how it helped finding the potential transportation black spots for government and road users through Artificial Intelligence (AI), Big Data Analytics and the implementation of Internet of Vehicles (IoV). Different cases of the Driving Safety Solutions and its opportunities and challenges were also shared and introduced.

iv) "Special Cargo Handling – Human Remains Delivery & Cargo" by Mr. Alan Leung, FCILT, Founder & Managing Director of A&G Logistics Ltd. on 19 October 2019

Suffering the loss of a loved one is one of the most sadness and difficult things we may face especially when unfortunate incident happened overseas. This was the second seminar conducted by Mr. Alan Leung, FCILT, in relation to Human Remains Delivery and Cargo since 2017. In this seminar, Alan invited two more guest speakers, Ms. Chole Ying, make-up artist; and Mr. Yin Chow, a transportation company owner, to illustrate more specially the overall operations from receiving order, arranging documentation, handling the remains till the delivery of the remains from mortuary to the board of aircraft from their first-hand experience.

v) "Following a Maritime Casualty – Adjusting Averages" by Mr. Raymond T.C. Wong, Principal, Asia Maritime Adjusting (Hong Kong) on 21 November 2019

This seminar was contributed as a supporting event in the Hong Kong Maritime Week (HKMW) 2019. Given numerous issues and questions would be arisen from a major casualty occurred during a common maritime adventure; but each set of circumstances are different. Mr. Wong focused on the General Average per York-Antwerp Rules and Salvage under Lloyd's

Open Form to explain handling of various types of claims with emphasis on the collection/provision of security from/by Concern in Cargo under multi-bills of lading and Containers. Furthermore, Mr. Wong briefly introduced the profession of average adjusting and its history in Hong Kong in the seminar.

vi) International Symposium on Road Congestion Charging on 3 December 2019

CILTHK joined other three professional institutions in Hong Kong in organising the International Symposium on Road Congestion Charging (ISRCC) on 3 December 2019 at the Sheraton Hotel. The three co-organisers were the Hong Kong Institution of Engineers – Logistics and Transportation Division, Intelligent Transportation Systems Hong Kong, and the Chartered Institution of Highways and Transportation (Hong Kong region). We were honoured to have Mr. Chan Fan, Frank, JP, Secretary for Transport and Housing of the HKSAR Government, as the officiating guest.

The symposium attracted over 160 participants, comprising local scholars and professionals, government officials and members of the public to attend. In this one-day Symposium, twelve renowned overseas and local experts were invited to share their knowledge and experiences on how road congestion been dealt with in other countries. The experts' sharing was conducted in below four sessions:

- Smart Mobility and Congestion Charging
- Planning and Implementation of Congestion Charging Schemes
- Congestion Charging Technologies I
- Congestion Charging Technologies II
- vii) "Quick Technical Fixes for the Pain Points of HK's SME Logistics Services" by Mr. Felix Wong, Co-founder of Acquaintance Enterprise Ltd (LOGFLOWS); Mr. Kelvin Wong, CEO of Sensestek Solutions Ltd. and Mr. Hugo Chan, Founder & Managing Director of X Group on 16 December 2020

The digital age for the logistics sector has come, it is important for the logistics service providers to upgrade their knowledge on the application of innovative technology and go hand-in-hand to remain competitive in the increasingly challenging business environment. The main challenge to SME is always insufficiency of business scale and resources. The seminar focused on the subject of 'How to address the related pain points to improve competiveness in the Hong Kong environment' which was worth exploring, particularly for the interest of the SME's. A panel of distinguished speakers shared updates of the latest technology in the logistics sector covering hardware, software and methodology for expanding the business. The sharing led fruitful discussion with the participants.

viii) Webinar "How MTR keep people moving & where do we go from here" by Ir Dr. Vincent Ho, Head of Corporate Safety; Ir Felix Ng, Senior Manager – Global Operations Standards and Ir Alex Lau, General Manager – Safety & Quality of MTR Corporation Ltd., on 23 April 2019

This was the first activity organised via ZOOM by PMAC to members since the cessation of the Institute's professional activities after the outbreak of COVID-19 in early 2020. Public transport is an essential service in moving the community, even in times of pandemics, to provide access for essential

personnel to reach their destinations. As one of the sectors significantly affected by the outbreak of COVID-19, MTR has been maintaining the operation through this challenging time whilst containing the health risk. The three senior executives from MTR introduced how MTR responded to the COVID-19 pandemic crisis through preparedness, quick response actions, innovation and good practice sharing through this webinar. The substantial changes made to manage the organisation and serve the customers in this unprecedented rapidly evolving and uncertain environment were discussed.

# ix) Webinar Series "COVID-19: Impact on Logistics and Practical Responses'

CILTHK was grateful to have the tremendous support from a team of legal experts from Holman Fenwick Willan (HFW) in launching this webinar series that had been scheduled in June to August 2020 to discuss the liability issues arise when doing business in three areas, including Maritime Transport, Aviation sectors, Sale Contracts and Risk Management & Mitigation in light of the COVID-19 pandemic.

"Session I: Issues arising in Maritime Transport" by Ms. Joanne Waters, Senior Associate of HFW on 8 June 2020.

The first session looked at examples of the disruption which COVID-19 has caused in the maritime industry, affecting supply, demand, people and processes. Ms. Joanne Waters led the participants looking at issues arising from delay and means of mitigating delay in future shipments.

**"Session II: Issues arising in Aviation"** by Mr. James Jordan, Senior Associate of HFW on 22 June 2020

The second session discussed the challenges that have been created for the air freight industry as a result of COVID-19. From reduced capacity to significant demand increase for particular types of cargo on certain routes, Mr. James Jordan elaborated to the participants how to assess the changing risk and regulatory framework and to consider what steps entities need to take in their commercial contracts to protect themselves in a post-COVID-19 world.

"Session III: Issues arising in Sale Contracts" by Ms. Suzanne Meiklejohn, Senior Associate of HFW on 20 July 2020.

Session III focused on the most common issues arising out of COVID-19 within the context of commodity sales contracts, particularly force majeure. Ms. Suzanne Meiklejohn shared some real life cases to elaborate how they were helping their clients and in which cases taking account of some of the knock-on effects of the COVID-19, such as counterparty defaults, and offer practical tips for navigating these ongoing issues.

"Session IV: Risk Assessment and Mitigation" by Mr. Craig Neame, Head of Logistics Department; Ms. Joanne Waters, Senior Associate of HFW on 27 August 2020.

In Session IV, Mr Craig Neame and Ms. Joanne Waters introduced the self-developed 'Coronavirus Impact Model' to the participants. This model is the result of a series of international HWF workshops and their extensive discussions with senior key stakeholders across the shipping and logistics

sectors. It aims to map out the potential impact of the virus on businesses in the shipping and logistics industries which highlights some of the potential risks and impacts that might arise in the four dimensions of a company's business and acts as a tool to help businesses develop risk management strategies and solutions. The 2 speakers demonstrated how it could be used to assist businesses to identify risk and build resilience for the new normal.





#### Policy recommendations / Submissions

3. **2025** Air Quality Objectives Review, 11<sup>th</sup> October 2019 (https://www.cilt.org.hk/en-us/publication/file.aspx?id=23)

In response to the invitation from the Environment Bureau/Environmental Protection Department ("EB/EPD"), the Institute tendered views and comments on the findings of the AQOs review working group, in particular those proposed new measures

relating to road and marine transportation.

The Institute is in support of progressively tightening the air quality standards to achieve environmental improvement as a whole in Hong Kong. While we support most of the measures proposed by the AQOs review working group, we suggest more concrete implementation plans to be worked out. More incentives or subsidies should be given to the public transport operators to catch up with the upgrading of environmental improvement of vehicles / vessels in an early and practicable manner. In addition, more work should be done on the town planning, design and standard side to take note of the air ventilation system in development areas, to give priority to public transport users, to provide adequate facilities for the competing users, etc

Members wondered how the connection of the proposed transport modes with the existing public transport facilities might be; as well as whether the NDAs could have a direct transport service to major CBD areas.
